That during the project prioritisation process, the Technical Committee (TC) acknowledged that in previous years the transfer of identified savings from one project to another, at the end of the financial year had been problematic (ie late identification of savings, limited projects available to transfer funds to, transfer process requirements). In an attempt to simplify any future transfer process and alleviate those issues, the TC have agreed to over allocate projects to each financial year (project dependant typically between 5-10% of the value of the program). In the event that there is no transfer of savings required, expenditure claims on over allocated project will be carried over into the following financial year.

# 8 Update from the Roads and Transport Alliance

Luke Hannam advised that:

- RRTG assembly (emailed out 21 September) was to be held next week Tuesday 18 October and will be chaired by the Director General of TMR, Neil Scales.
- Identified at the Tech Coordinators forum, held last week at LGAQ, that not all members of the RRTG had made themselves aware of the new Operational Guidelines – (Guidelines are available on FNQROC website - Roads and Transport Alliance Operational Guidelines 2016

Darlene Irvine asked if queries raised at the forum regarding changes to the Operational Guidelines will be addressed.

Luke advised that whilst he was not certain, he was of the opinion that the Roads and Transport team were in the process of drafting feedback and outcomes from the forum. Luke advised that he would find out.
