The meeting commenced at 11.04am.

The Chair opened the meeting and acknowledged the Traditional Owners of the land on which we met today, paying respects to Elders past, present and emerging.

The Chair welcomed Brendan Moon and Assistant Minister Nikki Boyd who will be arriving later in the meeting.

2921 BOARD PRESENTATIONS

3.1 Mr Brendan Moon, Queensland Reconstruction Authority (QRA)

Mr Moon discussed the turnaround timeline to approve submissions and what strategies can be put in place to commence restoration works, (particularly in isolated communities) which minimises the impact on council's cash flows (rural/remote councils).

Overview

- Natural disasters in the Far North 36 events, \$1.22B in reconstruction Naas.
- Infrastructure grant programs 2020/21 DRFA 87 Projects \$225M (33 days)
- National Flood Mitigation Infrastructure Program 22 Projects \$50M (88 days)
- Works for Queensland 333 projects \$200M (55 days)
- 2020/21 Queensland Resilience and Risk Reduction Fund 82 Projects \$19.1M (108 days)
- Grant advances 30% of approved submissions upfront. Can draw down on those funds. Will pay against invoices and general ledger, as long as there is evidence.
- DDMG exercise planned for October 2021 how Councils' can work together during natural disasters.

The Chair asked for feedback/comments from the floor:

- Cr Scott What is needed to speed up the process to get information and acquittals through? Infield assessment model works. Tried digital environment but doesn't work very well. Coordinating timing. Position resources when submissions ready to be assessed.
- Cr Andrews Evidence of sink holes, don't have demonstrated evidence, need support. Seek advice from Dean Patchet, Regional Liaison Officer. If existed pre-disaster may be able to look at other funding streams.

The Assistant Minister thanked the Board for today's invitation and provided a State Government update highlighting the following areas:

- Four-year \$52.2 billion capital program
- Building our Regions
- Resources Community Infrastructure Fund
- State Infrastructure Strategy
- Regional Infrastructure Plans
- Remote Area Boards
- Works for Queensland
- Indigenous Councils Critical Infrastructure Program
- The Sustainability Framework
- Training programs
- Cost Shifting
- Financial Assistance Grant
- Release of the Local Government Sustainability Framework today 7 October 2021. (link to <u>website</u>)

The Chair asked for feedback/comments from the floor:

- 24 councils at risk of unsustainability prior to completion of the budget. Looking at ways to assist councils to sustainability. Support from the Department can be provided to Councils councils have put up their hand for examples, but this is yet to be provided.
- Extension of the grant funding timeframes and reporting milestones willing to extend aspects under the act. Extensions case by case. Delegation to approve/not approve sits with the DDG and none have been rejected to date.
- Councils voiced concerns around OIA. So many complaints proceed to investigations with little consequence. Councils have to budget to cover costs of investigations. DDG aware of feedback and are working with LGAQ to address concerns and ratios.
- Review of FNQ Regional Plan urgently needs reviewing. Is currently the oldest in the state.
 There has been considerable growth and housing approvals since it was written 10 years ago. It is currently constraining growth and we would appreciate support in getting this in the next review.
- Cook has submitted paper on sustainability framework. Not just about ratios it is about several elements (cost shifting to councils) that contributes to being unsustainable.

I am writing to thank you for your participation in the electronics stewardship roundtable discussions, co-hosted by the Department of Agriculture, Water and the Environment, and state and territory governments.

In Australia, we have schemes to recycle our televisions, computers, printers, mobile phones and batteries. But we still send hundreds of thousands of tonnes of potential resources valued at \$680 million to landfill every year. Without action, electronic waste volumes are projected to increase over this decade.

We need to do more. The Australian Government's ambition is that every device with a plug or battery can be recovered and treated as a valuable resource.

By contributing to the discussions, you are contributing to the solutions. The discussions have been a valuable opportunity to hear from you and others across the supply chain and broader society and to progress Australia's transition to a more circular economy.

The department will publish a discussion paper later in the year. I look forward to your submission to the discussion paper and future engagement, as we take this once in a generation opportunity to take a holistic first principles approach to transform e-waste into e-resources.

Policy No. 2 FNQROC Credit Cards

Intent

To clearly define the responsibilities of all employees involved in the use of FNQROC's Credit Cards.

Scope

FNQROC Credit Cards are available for use with the aim of improving the purchasing and payment processes for FNQROC in terms of cost, control, efficiency and effectiveness.

It is the intent of FNQROC to ensure it meets the Local Government Act 2009 and associated regulations.

Usage

The credit card is to be used for purchasing goods and/or services for FNQROC business purposes only.

Limits

Purchases can be made using credit cards up to the transaction and monthly card limits, approved for the Cardholders position responsibilities and financial delegation.

Documentation

Tax receipts are required to support all transactions and are to be provided to FNQROC within two (2) working days.

Misuse Of Purchase Card

Misuse of the purchase card by the Cardholder will lead to withdrawal of the card, internal disciplinary action or criminal charges and/or reimbursement of costs by the Cardholder.

Misuse includes but is not limited to the following:

- Deliberate private use;
- Procurement of goods, services and materials that do not align with FNQROC operational requirements i.e.
 could tarnish the professional reputation of FNQROC or where it has been directed as not suitable or
 surplus to requirements by the Executive Officer.
- Purchases that generally do not comply with Cairns Regional Council Policy relating to procurement, travel, entertainment, hospitality and workplace health and safety. If there is doubt, seek clarity from the FNQROC Executive Officer.

FNQROC Letters of Support

Intent

To clearly define the context in which a Letter of Support is provided by FNQROC without seeking support from individual member councils.

This policy will be implemented when Letters of Support are requested from FNQROC and after consideration by the Chair and/or Executive Officer are deemed to align with the regional priorities and/or direction of FNQROC.

It is agreed that when strategic alignment is met Letters of Support can be granted without seeking support from each member council.

- 1. Background information including how the request aligns with the FNQROC Strategic Goals
- 2. What are the issue to be addressed?
- 3. Term of the support
- 4. Regional outcomes of support
- 5. Concerns around any support
- 6. Key Performance Indicators

A summary completion report addressing the key performance indicators is to be presented at the next available FNQROC Board meeting.
