#### 6.1 Advocacy Update from FNQROC

6.1.1 Dam Study release

Will form part of the advocacy during the FNQROC Mayoral delegation to Canberra in August.

6.1.2 Mayoral Delegation Canberra - 30 Aug to 2 Sept 2021.

#### Proposing 6 advocacy topics:

- 1. CRC Building better regions application to scope 'Cairns and FNQ, Capital of the Smart Green Economy'
- 2. Yellow Crazy Ants
- 3. Roads additional ROSI Funding (Cairns to NT Border) and First and Last mile funding
- 4. Social Housing
- 5. Water Dam Study and Cairns Water Security
- 6. Northern Australia Agenda

#### 6.1.3 Water Update

- 19 April meeting with Deputy Prime Minister Michael McCormack and Hon Warren Entsch with attendance from Mareeba, Tablelands and Cairns Mayors. There was \$7m on table for a detailed business case for the North Johnstone Diversion.
- Due Diligence has identified:
  - o The State had engaged Sunwater to do the Concept plans. This is now with the State. At this stage they would not support an application for a detailed business case.
- FNQROC Board met with Minister Butcher on Wednesday 9 June 2021.
  - o The Tablelands Regional Water assessment was due to start in 2022 this has been pulled forward and they are looking for staff now to undertake this assessment earlier.
  - o All options for the region will be reviewed old (Nullinga and North Johnstone diversion) and any new ones i.e. 3 dam concepts as part of the Regional Water assessment.
  - It is noted the State is looking at dam safety and raising the level of some to mitigate against a changing climate (noting this provides security for existing industries, may not support growth)
- FNQROC will continue to push agriculture and the need for water for agriculture growth.
- FNQROC will continue to advocate the results of the Dam study which shows economic benefit in the longer term.

D Irvine provided some commentary on the feedback received from members and the changes to the FNQROC Strategic Goals (noting the goals are not in a priority order):

- 1. Develop resilient transport infrastructure and connectivity
  - Requests to include solutions to Kuranda this was not included as it doesn't take into consideration the role the Palmerstone can plan. Focus was put on all range road crossings.
  - Some of the issues have been rephrased into solutions
- 2. Provide reliable and affordable water and energy
  - The suggestion was made to make it two papers which has been done
  - The outcomes of the Dam Study have been included
  - Any Dam names references have been removed and a focus on urban and agricultural growth and water security instead.
  - We have included some reference to urban reticulation networks
- 3. Respect and manage our natural assets and environment
  - Chunks of works have been removed which portray doom and gloom
  - Recognition that our communities are custodians of international assets and this comes at a cost
- 4. Develop equitable social infrastructure
  - Figures have been updated some figures are quite old but they haven't been updated.
- 5. Provide equitable communication network

• To answer one of the queries – do we have an FTTP map – no we don't, D Irvine trying to get this from NBN but telcos generally keep this as a closely guarded. We do have a mobile communications map as a result of an on-ground audit.
