## 5. REGIONAL WATER CAPABILITY PROJECT – PAUL GILLIES & CHRISTINE IP, QUEENSLAND TREASURY CORPORATION

- Following endorsement by the FNQROC Board, the FNQROC Regional Water Capability project is underway with support from QTC
- The first steps have been completed which first involved understanding 'on-the-ground' capability with the completion of surveys by all councils followed by workshops to socialise the findings and key themes.
- The detailed results were circulated to the Water Alliance on 20 March 2023.
- QTC provided a summary of the key findings and then facilitated a workshop session to discuss and agree the initiatives that the Water Alliance would like to progress to the FNQROC Board for Options Analysis.
- The following initiatives were selected for investigations via an options analysis:

#### People

- Ability to attract and retain suitable, qualified staff to support the water and wastewater businesses
- Ability to provide training and upskill the existing workforce
- Ability to access external specialist contractors and consultants

#### **Processes**

The use of documented standardised operating procedures, processes, and templates to guide and assist with:

- capital planning
- capital deliver
- asset management
- procurement and contract management

### **Systems and Data**

Ability to record, store, access and analyse data, to better inform planning and decision-making activities for:

- capital planning
- capital deliver
- asset management
- procurement and contract management

## 6. LGAQ UPDATE – JENNIFER HARTWIG, LGAQ

## **New Governance & Bid Pool Funding**

Some important updates to Bidpool funding with the new QWRAP governance structure. Bidpool funding will be as follows:

- The working group can approve Bidpool applications under \$50K
- Projects over \$50k will need to go the PSC for approval.

Regional Coordinator funding is available to all regions and is no longer linked to maturity levels as the critical importance of the regional coordinator to the success of QWRAP is well recognised

No co-contribution is required for Regional Coordinator funding which is currently capped at \$35,000 per year. Bid pool funding is available for project management

#### **Bidpool Application Documents**

Bidpool criteria and application templates are being reviewed & updated. For the time being, the existing template can be used for applications. The new criteria aims to streamline the document and align the application process with the new Vision, Mission and Strategic Priorities.

#### **Annual Report**

The QWRAP Annual Report has been endorsed by LGAQ and the PSC. The report is now published on the QLD water website & LGAQ Congruent. The annual report has been well received and communicates the progress of the QWRAP over the last 12 months

#### **New Head of Advocacy**

Sarah Vogler is new LGAQ Head of Advocacy and will be replacing Glen Beckett in the QWRAP PSC. Glen is returning to his substantive role as Head of Assist, and we thank him for the work last year in development of the new QWRAP governance structure.

#### **Skills & Training**

New local government funding campaign called Indigenous Capacity Building Project 2022 to 2025. The purpose of the Indigenous Capacity Building Project (ICB) is to provide supported training places and pathways for Aboriginal and Torres Strait Islander people to participate in and complete vocational qualifications that lead to employment outcomes and support the skills needs of local small businesses. The ICB builds on the existing three-way partnership established through the Indigenous VET Partnership Program between LGAQ, Councils and Registered Training Organisations

The Department of Employment, Small Business and Training (DESBT) has contracted the LGAQ to manage funds for the implementation of the ICB project across the sixteen Aboriginal and Torres Strait Islander Councils in Queensland plus those councils with high Indigenous populations.

## 8. RDMW UPDATE - DINESHA EMMERY & RAQUEL ESTEBAN

#### **RDMW**

- DG is leaving to fill role as CEO of the Brisbane 2032 (Olympic) Coordination Office. Last day is 24 March 2023
- Linda Dobe will be acting DG
- Recently presented at the Cairns Water Supply Regulator Workshop and had the opportunity to catch up with many of attending the meeting today

#### Queensland's Urban Water Explorer (https://explorer.water@gld.gov.au)

- Soft launch was December 2022
- Feedback so far has shown good level of adoption
- Will be reconvening the working group to review/evaluate it
- Will be updating it with new 2021-22 in March-April
- Plan to promote more broadly in coming months

#### **QWRAP**

 As mentioned already by the other QWRAP partners, the program has undergone some strengthening and refinement through revision of its governance, clarification of roles and responsibilities and development of the program's Vision, Mission, targets, and priorities

## 9. QUEENSLAND HEALTH UPDATE - BRAD MILLIGAN & CHRISTOPHER LAND

#### **Single Barrier Systems**

Focus on single barrier systems currently due to increased rainfall in the region and added risks as a result and focusing on assisting with day-to-day incidents.

## 10. REEF CREDIT SCHEME, WASTEWATER METHOD PUBLIC CONSULTATION – SIMON PAGE, CASSOWARY COAST REGIONAL COUNCIL

Simon Page advised that he had recently received an email from Eco-Markets regarding the **Method for Accounting** for Nutrient Reduction in Municipal Wastewater Treatment Plans through Managed Bioremediation Operations – **Version 1.0** for use under the Reef Credit Standard.

The methodology quantifies the reduction of Dissolved Inorganic Nitrogen (DIN) and Dissolved Inorganic Phosphorus (DIP) discharged from municipal wastewater treatment plants through managed biomediation solutions.

Simon wanted to make the group aware of the involvement of this methodology.

ACTION POINT 33.5 FNQROC to circulate for information, the email received by Simon Page relating to Method for Accounting for Nutrient Reduction and the quantification of Dissolved Inorganic Nitrogen (DIN) and Dissolved Inorganic Phosphorus (DIP).

#### 11. PFAS

FNQROC made a submission on the Draft PFAS NEMP 3.0 supporting the comprehensive submissions of both QLD Water and LGAQ.

Cassandra Budd of Mareeba Shire Council advised:

- MSC has engaged with Queensland Alliance of Environmental Health Sciences (QAEHS) to assist with PFAS sampling plan across the WWTP in response to the draft NEMP 3.0 and potential for adoption of PFAS biosolids thresholds in the EOW code
- Initial investigative samples have been taken as a first step to map PFAS across the WWTP. The goal is to use the data for an RA on biosolids and release water.
- Worth noting that QAESH <a href="https://qaehs.centre.uq.edu.au/">https://qaehs.centre.uq.edu.au/</a> is a research centre jointly funded by Queensland Health and The University of Queensland. They are not a NATA certified lab but lead research in this area.
- The Sewerage and Water Environmental Advisory Panel (SWEAP) (qldwater) met on the 16<sup>th of</sup> March and discussed:
  - ARC sewer catchment project (SEWAUS) <a href="https://qaehs.centre.uq.edu.au/sewaus-2021">https://qaehs.centre.uq.edu.au/sewaus-2021</a> invitation to participate in annual survey
  - Research projects. We discussed potential for qldwater/SWEAP? to fund early career researcher
    project that could look at this investigative work at WWTPs and a standard approach to risk
    assessment. My thoughts here are if we are aligned with our methodology and language,
    communicating the results and risk will be easier invitation to get involved
- Louise Reeves from gldwater has been heading up conversations with QAEHS

#### Chlorate Testing - Adam Schmalz - Cairns Regional Council

The following question was forwarded by Adam as an agenda item for discussion:"

'Are member councils currently testing for chlorate in their DW schemes and are they reporting exceedance of the QH guideline value of 0.8mg/L as a "detection of a parameter with no guideline value which may impact public health". If so, are they investigating right through the supply chain and have they had feedback from Coogee as the FNQROC supplier of hypo?

Adam advised that he was interested to know how far drinking water service providers are going to rectify any issues and what successes that ayre having. Cairns Regional Council are in the process of looking at improved process and supply chain solutions.

Cassandra at Mareeba Shire Council advised that she had recently commenced a project looking at this. Brad at QLD Health advised that they were doing work with some remote supplier regarding storage and supply. Amanda noted that FNQROC enjoys a strong relation with Coogee who she is confident would be happy to work with councils to assist where possible.

#### Water Industry Worker - Amanda Hancock, FNQROC

An email was circulated on 21 March 2023 with details of the Water Industry Operations (WIO) qualification. Simmonds & Bristow have been successful in their submission to the Water Industry Worker Program.

Interest is also being sought from councils who wish to attend Biological Nutrient Removal Wastewater (Engineering level course) which is a 5-day course. There are talks currently underway with Townsville (NQ Alliance) to access QWRAP funding for the coordination of a course to run in Townsville at JCU instead of Brisbane later this year. Councils indicated a good level interest in nominating candidates for this training.
