#### Discussion - business arising from previous meeting

#### 63.1 Feral pig management on State Land (QPWS)

Chris Roach provided an overview of key programs and operational management of feral pigs on national parks.

**Internal funds** Parks conducts routine management of feral pigs across its land, programs are place-based and are targeted to the protection of identified values like wetlands, threatened species or visitor assets. Internal funds are allocated in accordance with management plans through a submission process.

**External funds** QPWS also secures external funding to deliver programs that meet State and National priorities. An example of this is the turtle predation protection program on Cape York.

**Boundary and cross boundary programs** Parks also conduct or contribute to cross-boundary management programs with internal and external funding or operational resources including traps and staff time.

The committee discussed the ins and outs of feral pig management across boundaries and within National Parks.

**Action:** Formally invite a suitable representative from QPWS to participate in the NAMAC (Coverage to include coverage of the 3 bioregions of FNQROC.

#### 8 General Business

#### 8.1 Feral Pig Carcass Disposal

Draft correspondence and option for advocacy delegation to State planned or Feb 2026.

The committee discussed key developments and information

- Rural landholders have a level of exemption for on -site hollow or pit for disposing of waste produced on the farm.
- Publications or guidelines are available for carcass disposal in an emergency response, but are not provided for day-to-day operations, or at volume.
- By DESI's ruling a disposal pit operated by a council is a facility for the disposal of waste that requires an ERA 60 waste disposal environmental authority.
- Being long-term as opposed to short-term has some bearing on the definition.
- Seeking clarification of the circumstances where a feral animal carcass is regulated waste (vs general waste.
- Whether an exemption like that provided to rural landholders could be established for LG pest control and road management programs.

**Action:** 1. review discussion paper with updated information. 2. Arrange discussion between relevant parties to align policy and advocacy conversation.

# 8.2 Meet, greet and workshop session: Emma Atkins – Regional Biosecurity Lead – North

Emma provided an overview of the program rollout. Items discussed included the biosecurity officer recruitment targets. 2 additional positions will be recruited for the north region. Teams will be based across the region including Torres Strait and NPA.

One of the priority pieces of work will be to develop a biosecurity risk assessment for the region. This will inform future programs and investments and influence the implementation model for each region. The team has been undertaking face to face consultation with stakeholders right across the region to get a handle on the requirements and priorities for the region.

# **8.3 Operational and strategic updates –** LGs, NRM, BQ Terrain NRM, Cape York NRM, Gulf Savannah NRM

#### 8.4 Land Protection Fund – update

The committee discussed the benefits and costs associated with the Land Protection Fund and the co-contribution process. There was agreement the region benefited from the research programs generated by the fund. It was acknowledged a lot of this success was attributable to local governments level of engagement with research programs. It was noted the reporting for the coinvestment had improved significantly since the last review. The main concern for NAMAC was the current calculation methodology and the relevance of Gross Value of Agricultural Production (GVAP) in the equation. The high value agricultural industries which influence the outcome of the calculation do not usually have a strong engagement or relevance to local biosecurity plans (advanced ag industries are generally insular in their pest management programs). Other GVAP concerns were the inclusion/influence of aquaculture in the calculation when the industry has no bearing on local plans or LG jurisdiction. There will be a call for representatives for the review in 2026.

**Action:** FNQROC nominate a representative for the Land Protection Fund – Co-investment Model methodology review.
