The Chair welcomed everyone to the meeting and acknowledged the Traditional Owners of the land on which we met and paid respects to Elders past, present and emerging.

3260 BOARD PRESENTATIONS

1. Discussion with Senator Susan McDonald

Senator McDonald acknowledged the work of the FNQROC Chair and Board Members, and thanked the Tablelands Regional Council for a fabulous event.

The Senator also acknowledged Shannon Fentiman, and Retired MG Jake Ellwood 'bringer of solutions', and greatly appreciation of his work.

The Senator advised that over the last couple of months she has spent time in Croydon and enjoyed being part of the region. She apologised for not being available to meet during the delegation, due to time constraints and other commitments but said "I am your servant" and noted her commitment to report on the region's issues.

Fun fact: of the 151 members of parliament and 76 senators, only 12 are in northern Australia. As the state which provides the food and fibre to Australia, the Senator is determined that the region gets its fair share of budgetary allocations.

The Senator acknowledged that the three advocacy priorities are all well targeted, but they are hard to get traction in Canberra. Suspect part of it I due to base funding being provided, however grant rounds being discretionary is unacceptable for this region, when we need significant roads and services.

The Chair noted the lack of staff to do the grant writing. Cr Millwood noted the importance of timing of FA Grants.

The need for safe and secure national freight routes is understood more than anyone by this region. A recent visit to the Woolworths distribution visit showed that there is sufficient space to plan ahead for events, it is the roads which block transport to the region.

Regional and Remote Special Economic zone has been a burning passion for a long time. Understand the great cost of doing business in North Australia hasn't been increased since early eighties, and now doesn't go near what's needed.

The Chair noted that during the ROC assembly which she recently attended, Senator Corrine Mullholland mentioned the need to push for FA Grants, which was well supported.

Cr Hughes thanked the Senator for all her hard work and said that he can see a shift in the way ROC Councils are looking at core issues impacting the region and can see mobilisation in that space, at the right time. To have someone in Canberra supporting the region is appreciated - urge councils to make use of that as grass roots providers.

2. QRA, Regional Reconstruction

The Presentation is available on request.

Key points:

- Current statewide program \$14.9 billion, 58 events, 76 councils with an active program, \$279.4M DRFA Cat B, \$3.3M Cat C&D direct to Councils and \$66.3M approved via State Department led programs
- LRAPS ensure they are up to date to access targeted funding programs. All councils have until 30 June 2026 to finalise their LRAP
- Qld Resilience and Risk Reduction Program (QRRRP) new approach to providing annual funding through efficiencies achieved in the delivery of the DRFA.
 - Aims to improve resilience via 3 core initiatives:
 - Qld Betterment Fund
 - Qld Resilience and Risk Reduction, and
 - Hazard and Risk Priorities Fund
- \$450M QRRRP delivered over 5 years includes \$40M per year to deliver high priority Betterment projects.
- Disaster Ready Fund (DRF) is a competitive program, don't lose heart if your grant application doesn't get through, if it is a priority put it on the LRAP.
- Accuracy of applications. There is an extensive multi-audit process for applications which will pick up ineligible claims.
- · Colvin Review of Commonwealth Disaster Funding:
 - Restoration is sacrosanct don't want to lose it to more resilience. It is the States
 not impacted by disasters who are complaining it is not working for them there
 has been a push to for less restoration funding.

 Insurance – insurance companies currently operate on latent flood data. Focus needs to be on mitigation undertaken. QRA have requested for process to include up to date flood data.

Questions from the floor;

 In some instances, flood resilience is not an option - the buyback scheme is appropriate in such cases.

QRA advised investment needs to be in shoring up bulk of vulnerable homes. Bray Park example the details of voluntary home buy backs wasn't just about flooding, it was about risk to life (height and velocity).

 It was commented that there needed to be a consistent policy on how buy backs occur throughout the state.

Mr Ellwood advised it's a difficult thing to standardise because every home and incident is different.

Commend QRA on focus on resilience. Seeking understanding around approval
process following an event – how do Council's advocate for some of the packages,
allocative not competitive funding, still waiting on some guidelines to be approved.
Haven't seen the environmental guidelines and funding for coastline. Request
process for guidelines and packages, streamline approval of guidelines, facilitating
release of funds ahead of a event.

QRA – Guidelines can't be written until after a package is announced. Environmental package – guidelines turnaround now 60 days. Standard guidelines are now being used for standard packages but it does depend on the package. If we get guidelines wrong, i.e., package for small business is always a finite amount of money, if guidelines are written for the wrong part of the community or spreads it so wide that everyone expects to get it, the guidelines have to be rewritten, which adds to the delay.

 One positive out of TC Jasper was the \$1m issued per council, allowing them to prioritise high priority activities including psychosocial impact and compounding psychosocial impact awaiting for the next event. Noted it was waterways which were overwhelmed, rather than drainage – larger local governments can facilitate through rates, however, that is not an option for smaller councils.

QRA noted the comment and will put through request for \$1million every time there is an event. Suggested a community relief fund could assist.

3. Discussion with Hon Shannon Fentiman – Shadow Treasurer, Shadow Minister for Women

Ms Fentiman thanked the Board for including her in the meeting and congratulated the reelected Chair and Deputy Chair. She acknowledged the challenges within the region and expressed that she would like to be part of those conversations. Looking forward to hearing more from FNQROC and finding out how her office can help. Has been making way around the Chambers of Commerce discussing biggest challenge, being stamp duty on insurance.

4. Lucy Green LGAQ, Lead Intergovernmental Relations (LGAQ)

Ms Green gave an overview of the Briefing Report circulated prior to the meeting. Key points;

- LGAQ Annual conference on Gold Coast set to be a big event preliminary agenda with motions were release last week.
- 133 motions have been received. Lots in the waste space, cemeteries, childcare spaces.
- New research project was released a couple of weeks ago call out if help needed to complete the survey – it's been simplified to make it as easy as possible. Great number of cost shifting feedback received.
- Depreciation task force LNP initiative on election, also working federally.
- Board members are encouraged to reach out to LGAQ if anyone wants to meet with shadow ministers at the conference.

3263 BOARD REPORTS

1. B115 – Outer Regional and Remote Special Economic Zone (R&R SEZ)

Ms Irvine provided an overview of the brief, requesting approval to create a suite of opportunities to support the R&R SEZ.

Key points;

- Invest in regions which are green field and ready to support the nation
- Helps release the pressure
- Encourage people to come to the region.
- Thanks to Neil for brain dumping

From the floor:

 How can we extend it to people in the area that we don't want to lose, to retain existing residents.

CEO advised this is a concept only stage and that is a detail within the concept if the concept is approved, can then formulate the finer details. Much of what is in the concept can apply to existing residents, not just new ones.

- It was noted that the strategy is part of a much bigger puzzle. Etheridge has lost approx.
 50% of the population over the past 15 years, but this is so intrinsically linked to other matters. Important to hang on to what we've got, but also sustain and grow economic development and population increases in the regions.
- It was suggested that it needs to be unpacked to drill down on impact on particular areas as it may work for some but not for all.

CEO confirmed that the R&R SEZ is a work in progress and it is envisaged to be a suite of opportunities which can be tailored into a package appropriate to the needs of each area.

 It was noted that the biggest barrier is in the planning system – it's a challenge in Cook Shire and needs to be addressed. In some areas there are layer upon layer in the planning scheme.

CEO advised that a lot of this is related to the state planning policies and hopes that it will be addressed within the red tape reduction. There are some planning elements in the R&R SEZ

It was noted that insurance costs are a significant problem.

CEO advised insurance stamp duty had been included.

• It was asked if a workshop on this was to be arranged.

CEO advised that once it goes out hope to collaboratively work with other ROCS to build on it.

• It was noted that the isolated children's allowance component is not included – Cook don't get it as the school isn't classified as low socio-economic school. It is important that this is included regardless of low socio-economic classification.

The CEO advised that she would include this.
