1. Policy Executive Meeting Update

- The Policy Executive met on the Gold Coast on Sunday, October 19, ahead of the LGAQ's 129th Annual Conference.
- The Minister for Local Government, Water, and Volunteers, the Hon. Ann Leahy attended the
 meeting alongside her director-general Bronwyn Blagoev, to give the Policy Executive an
 update on key portfolio issues and to take questions from Policy Executive members on issues
 of importance to councils across the state.
- Other key items on the agenda included:
 - Queensland Freight Delivery Plan and Freight Subsidy Review: The Policy Executive was updated on the consultation underway regarding the Queensland Freight Delivery Plan as well as advocacy regarding the review undertaken by the State into the freight subsidy. Members were also given a further update on this issue at the Roads and Transport Forum on the Monday of Annual Conference with both the Minister for Transport and Main Roads, the Hon. Brent Mickelberg, and his Director-General Sally Stannard and Deputy Director-General Andrew Mahon in attendance.
 - Community Benefit Agreement Template and Local Government Guidance: The Policy Executive was updated on key work underway to support councils to navigate the new community benefit framework. Policy Executive members have also shared the work underway by their own councils, as well as by councils within their Policy Executive districts, to help inform this advocacy work.
 - Cemeteries Research: The Policy Executive was updated on the finalisation of the body of research work into cemeteries and the issues facing councils and communities across the state. The research was the subject of a panel session on Tuesday at Annual Conference as well as a Policy Executive Motion that was debated and subsequently passed by members on Wednesday.  - First Nations Housing: The Policy Executive was updated on ongoing advocacy to secure funding for remote First Nations housing to end overcrowding across rural and remote communities.
 - Statewide awareness campaign: The Policy Executive was briefed on the chosen concept behind the LGAQ's new awareness campaign to be launched on behalf of members, to help inform the community of the vital work of councils. This is a key piece of work undertaken by the LGAQ each term.
 - Cost-shifting survey: The Policy Executive was given an insight into the early results coming in from the latest cost shifting survey launched with members. Those results are showing the figure is already on track to surpass the \$360 million in cost-shifting uncovered in the last survey, released last year.  - State of the Assets Report: The Policy Executive approved the 2025 Queensland State of the Assets report ahead of its launch at the LGAQ Annual Conference on Wednesday. The report was compiled for members with the support of the Institute of Public Works Engineering Australasia. You can read the report here.  - Other key items: Other key items to come to the Policy Executive at its October meeting included work underway regarding the Prosper 2025 Plan as well as updates from Chief Digital Officer Tracy Whitelaw and Head of Assist Brett Johnson. Policy Executive also discussed pre-notified items of general business raised by Policy Executive members including the issue of safety of elected members, the ability of councils to be able to invest outside Category One investment powers under the Statutory Bodies Financial Arrangements Act 1982 so they can support financial institutions to continue to operate locally and regionally, and the need for councils to be represented as part of the Hazards Insurance Partnership.



- Key projects: The Policy Executive was updated on key projects being delivered by the LGAQ on behalf of members including the Cleaner Road Runoff Project, the Domestic and Family Violence Prevention Project, the First Start Program, the Indigenous Capacity Building Project, the QCoast2100 Program, the Queensland Climate Resilient Councils Program, Queensland Council Energy Partnerships, the Queensland Water Regional Alliance Program and the Rural and Remote Capacity Building Project. This update included a video detailing the work of the Queensland Climate Resilience Councils program.
- The next meeting of the Policy Executive, and the final meeting for 2025, will be held on Friday,
 5 December.

2. Empowering Councils Bill introduced

- A new Bill has been introduced into State Parliament to amend the Local Government Act 2009 (LGA), City of Brisbane Act 2010 (COBA) and associated regulations and the Local Government Electoral Act 2011 (LGEA).
- You can read the Local Government (Empowering Councils) and Other Legislation Amendment Bill 2025 here and the Explanatory Notes here.
- Some of those amendments include:
 - o Removing conduct breaches from the councillor complaints framework. The definition of misconduct will be amended to include more serious conduct breaches, namely bullying, sexual harassment for investigation by the Office of the Independent Assessor and determination by Councillor Complaints Tribunal.
 - Amending section 12 of the LGA to put beyond any doubt the longstanding position that the mayor is the official spokesperson of the council.
 - o Amending section 14 of the COBA and section 12 of the LGA respectively to reinforce that all councillors have a responsibility to communicate with the community on local government issues, but that they are doing so as individual councillors, not as the official spokesperson on behalf of the council.
 - o Amending section 12 of the LGA to put beyond doubt that the mayor of a local government is the default chairperson for ordinary and special meetings of the local government, which includes managing the conduct of the participants at the meeting. This change will not apply to the COBA, nor will it apply to council standing committees with the chairperson of a standing committees to continue to be determined in accordance with section 267 of the Local Government Regulation.
 - o Amending various Acts to only require new candidates for a quadrennial election, a byelection or a fresh election, to complete mandatory candidate training. Returning councillor/candidates would not be required to complete the training if they had already done so previously.
 - o Replacing the current conflicts of interest framework in the COBA and LGA with the previous framework that was in place from 2013 to early 2018, with some minor modifications. This includes:



- The removal of the requirement for non-conflicted councillors to vote on whether to allow a conflicted councillor to participate in decision-making.
- The removal of the concept of a 'close personal relationship' with a councillor from conflicts of interests.
- The removal of the duty on a councillor to report a belief or suspicion of another councillor's conflict.
- Reinstating the concepts of material personal interest and conflict of interest
- Retaining the current conflict of interest exceptions for councillors such as, small value gifts and hospitality, club memberships, religious beliefs and political affiliations; and the current ordinary business matters of a local government, including the development of whole of local government documents such as the budget and operational plan.
- Updating the framework for dealing with breaches, including penalties:
 - serious breaches (that is, the intention to gain a benefit, or avoid a loss, for a councillor or someone else) – maximum penalty of 200 penalty units or 2 years imprisonment, and,
 - other breaches dealt with as 'misconduct' under the councillor conduct framework.
- Removing the requirement for an election candidate and other participant to include their residential address in election material. Instead, a candidate or participant would be given the option of including other contact information, for example, a PO Box address.
- Providing for a general approval to make major policy decisions about Disaster Recovery Funding Arrangements assistance during local government caretaker periods, removing the need to seek a ministerial exemption for each contract.
- Clarifying rating powers for First Nations local governments, including providing a framework to enable these councils to levy rates in the future. The LGAQ will continue to work with the Minister, Department, Valuer-General and members to progress this.
- The Bill includes an amendment that is currently contrary to an existing member position an amendment to automatically remove a councillor or mayor from office if they nominate to run for election to State Parliament.
- The LGAQ will be consulting with members on this change as well as on all other amendments within the Bill.
- The Bill has now been referred to the Parliamentary Local Government, Small Business and Customer Service Committee for consideration.
- The Committee is due to report back to Parliament on the Bill by 30 January 2026.
- A closing date for submission had not been nominated by the Committee at the time of writing.

3. LGAQ Annual Conference Final Outcomes document and key releases

- Following Annual Conference in October, the LGAQ has now released the Final Outcomes
 document containing the outcomes from the Annual General Meeting on the Wednesday of the
 LGAQ's 2025 Annual Conference.
- Of the 133 motions put forward for debate at this year's Annual Conference, 126 were passed and are now resolutions to be progressed by the LGAQ team on behalf of member councils.
- Letters containing the 2025 resolutions have been circulated to State Ministers and Directors-General.



- Letters will also be circulated to the relevant Federal Ministers and Department Secretaries following the LGAQ's delegation to Canberra in the first week of November.

4. Queensland Indigenous Council Leaders Accord signed

- The Queensland Indigenous Council Leaders Accord was signed ahead of the Indigenous Leaders Forum at the October Annual Conference.
- The Accord was signed by Local Government Minister Ann Leahy, Aboriginal and Torres Strait Island Partnerships Minister Fiona Simpson, LGAQ President Matt Burnett and LGAQ Policy Executive members, Lockhart River Aboriginal Shire Mayor Wayne Butcher and Palm Island Aboriginal Shire Mayor Alf Lacey.
- This historic agreement guarantees First Nations leaders a seat at the policy-making table to secure real outcomes for their communities.
- Discussion with members will now commence regarding the timeline of future meetings and priority issues that will inform the Accord's agenda.

5. Roads and Transport Update

Queensland Freight Delivery Plan (QFDP)

- The Department of Transport and Main Roads has begun consultation with stakeholders on priorities for the refreshed QFDP that will shape future investment and policy to improve freight efficiency, resilience and regional connectivity. There is a strong focus on first and last mile access, freight route resilience and aligning infrastructure with regional economic development.
- The Department of Transport and Main Roads has hosted the first round of consultation workshops to inform the delivery plan and ensure it reflects regional freight challenges, with a North Queensland workshop held on 24th October 2025 and a First Nations workshop held on the 31st of October.
- Further opportunities to provide input into the development of the QFDP will be issued in the coming weeks.
- The LGAQ will prepare a submission on the freight challenges for councils and is seeking feedback on issues such as freight costs, access and logistics, infrastructure constraints, seasonal impacts and challenges experienced in First Nations communities. State of Australia's aviation sector and its ability to deliver reliable and affordable services to rural, regional and remote communities



- The Rural and Regional Affairs and Transport References Committee has an ongoing inquiry into the state of Australia's aviation sector.
- The inquiry focuses on the current ability to deliver reliable and affordable services to rural, regional and remote communities with particular reference to:
 - Costs, fees, levies, taxes and charges that are core components to the pricing of airfares
 - Disparities of these costs across rural, regional and remote airports
 - Mechanisms for recovering federally mandated security and regulatory costs and options for achieving greater financial equity across the aviation sector
 - Competitiveness of the aviation sector to service regional, rural and remote communities and the implications of reducing or withdrawing those services
 - Adequacy of government fees and levies to equitably address costs for airline services incurred due to federal legislation
 - Effectiveness of government processes and mechanisms to identify and quantify capital and ongoing costs due to federal legislation and regulations
 - Policy or practical measures that could be established to assist the aviation sector in providing services to rural, regional and remote communities
- The LGAQ will develop a submission on behalf of member councils and seeks feedback on this

Federal Productivity Inquiry into Regional Airfares

- The Federal Productivity Commission (The Commission) has announced they will undertake
 an inquiry into the determinants of regional airfares.
- The LGAQ highlighted challenges associated with the cost of regional airfares in a submission on the Aviation White Paper.
- The Aviation White Paper found that the average ticket price per kilometre was 52 per cent higher for flights involving regional airports than for flights between capital cities.
- The Commission will conduct a review of the determinants of regional airfares in Australia and make recommendations on policy settings to support a competitive, reliable and affordable regional aviation framework.
- Terms of Reference for the Inquiry have been released and can be found <u>here</u>.
- The Commission will release an issues paper in due course, with submissions expected to be sought by the Commission in early 2026.
- The LGAQ will be collating a submission on behalf of member councils and will reach out to member councils and ROCs for information and case studies in due course.

Accepted development requirements for waterway barrier works

- The Department of Primary Industries has released Version 2 of the Accepted development requirements for operational work that is constructing or raising of waterway barrier works (ADR).
- Consultation on the second version of the ADR commenced in September 2024, and the
 updated version reflects significant progress on issues long raised by councils and the LGAQ.
 The revised version marks a more practical and workable framework for local government
 infrastructure delivery.
- The new ADR introduces important updates for disaster recovery works on essential public assets. Councils are now able to repair or replace damaged infrastructure in like for like condition within the same or similar footprint for government-funded recovery works, with scope for betterment where appropriate.
- The changes also include:
 - o Greater flexibility provided for use of gabions in common scenarios
 - o Simplified requirements for western drainage basins



- Rock sizing requirements for aprons and waterway bed scour protection have been made more flexible across amber, red and green waterways
- Greater flexibility for cover requirements around culverts in green, amber and red waterways.
- A transition period of one year to continue utilising the old version of the ADR
- Councils are encouraged to review the new requirement and how they may apply to their delivery programs. You can find the new ADR here.

6. Public Health Update

Animal Management

- The next scheduled meeting of the Animal Management Technical Working Group is set for Thursday, 11 December.
- The LGAQ continues to advocate for further reforms and a broader review of the *Animal Management (Cats and Dogs) Act 2008* through the Taskforce and Working Group.

Queensland Civil and Administrative Tribunal Act review 2025-26

- On 23 May 2025, the Queensland Government asked the Honourable David Thomas to review
 the Queensland Civil and Administrative Tribunal Act 2009 (QCAT Act), which must be
 reviewed every 5 years.
- A project team in the Department of Justice (the Department) is supporting Mr Thomas conduct
 the Review. The terms of reference from the Attorney-General are available for download on
 their <u>website</u>. The final report is due to be delivered to the Attorney-General by 30 April 2026
 and will be tabled in Parliament.
- The LGAQ is preparing a submission in response to the review.
- The LGAQ facilitated a webinar on Tuesday, 28 October for councils to provide feedback to inform the submission.
- A second webinar was held by the Department on Friday, 28 November to inform councils of the review.

7. Water and Wastewater Update

Quantifying the Infrastructure Cliff Research Project

- Since subsidies stopped in 2008, there has been no dedicated, ongoing State Government funding program to support local government in the renewal and replacement of aging water and sewage assets.
- In 2018/2019, QWRAP funded research reports found the renewal of water and wastewater infrastructure assets reaching the end of useful life would be critical in the next few decades, estimating the cost to replace in ground assets alone would be as high as \$1.8 billion by 2030 and \$3.8 billion by 2040 at current replacement rates.
- In 2025-2026 financial year, the LGAQ has committed funding for a new research project to be undertaken to establish a contemporary evidence base.
- This new project seeks to quantify the scale, age, and condition of ageing water and wastewater infrastructure across Queensland councils to determine the extent of assets nearing end-of-life ('the infrastructure cliff').



- This research project will support ongoing advocacy around a better funding framework for councils faced with the challenge of the infrastructure cliff, aligned with the water and wastewater PE resolution passed to at this year's LGAQ Annual Conference and build on previous research undertaken through the QWRAP program as well as more recent LGAQ research on Queensland State of Assets and infrastructure funding gaps.
- The LGAQ has procured PSA Infrastructure to commence work on the project and expect a final report to be delivered in early 2026.

8. #BinTheTax Campaign

- The LGAQ's #BinTheTax campaign on behalf of 19 councils impacted by the State Government reduction in the offset paid to councils to stop its waste levy being applied to household bins continues to drive community engagement and awareness.
- At the recent Annual Conference, councils <u>came together</u> to call for the urgent investment and action they need to chart a fairer path to reducing waste and increasing recycling for communities across the State.
- These priorities informed a <u>six-point plan</u> released by the LGAQ.
- Targeted paid social media has so far reached over 100K Queenslanders and driven over 8,000 to the campaign webpage.
- On August 18, the LGAQ released polling which showed that nearly 7 in 10 Queenslanders oppose households paying a levy on their household rubbish, continuing to generate media coverage in support of the campaign.
- Councils can utilise a <u>suite of assets</u> in support of the campaign as well as order <u>bin stickers</u> or contact Campaign Manager Sam Dean to discuss opportunities to collaborate.

9. The 2025 Cost Shifting Survey

- On 4 August the LGAQ 2025 Cost Shifting survey was launched with information sent to Mayors, CEOs and Finance Managers.
- The LGAQ's first cost-shifting report, released in 2024, has been a powerful tool for our advocacy, providing data and examples of where councils have had to step in as providers of last resort because the other levels of government or private sector have stepped back or stepped out of providing the services our communities cannot go without.
- We believe the actual financial impact on councils is even greater than was uncovered in that 2024 report.
- We have sought to simplify the information request, and we appreciate the work required by councils to respond.
- The resulting report and its release will continue our campaign for a fairer funding deal for Queensland communities, further building on our momentum of recent State and Federal election campaigns.

10. Local government awareness campaign

 As residents look to local government for more than ever before – despite declining levels of funding and increasing costs shifted onto councils and ratepayers – it's an important time for the local government sector to tell its story.



- The LGAQ is currently working on an awareness campaign aiming to improve understanding
 of the roles and responsibilities of local government. The campaign will be 'always-on' and
 give councils the opportunity to localise and tailor messaging.
- To ensure this campaign resonates with communities in all corners of Queensland, the LGAQ
 has been conducting research into what Queenslanders think about local government.
- A summary of this research can be viewed <u>here</u>.
- Council feedback on the campaign has been collected and is currently being used to inform asset creation to ensure this campaign can be highly tailored and localised across Queensland.
- The campaign will be first in market from early 2026 and councils will receive information on how to utilise and leverage the statewide key messages and creative.

11. Depreciation Taskforce

- In August 2025, the Queensland Government established the Local Government Depreciation Taskforce (the taskforce) to tackle the challenges councils face to effectively and accurately manage growing depreciation costs.
- The Taskforce is being led by Mr Neil Castles, who has significant experience both in State Government and the Queensland local government sector, including 23 years at Queensland Treasury Corporation.
- This Taskforce comes off the back off the now Premier's election commitment of establishing a review into depreciation announced at the LGAQ's 2024 Annual Conference.
- The Taskforce's main objective is to identify the challenges for councils in managing depreciation expense, present opportunities to reduce the impacts of depreciation on councils' sustainability and enhance stakeholder awareness of the implications of depreciation on investment decisions.
- The Taskforce reports to the Minister for Local Government and Water and Minister for Fire, Disaster Recovery and Volunteers, the Hon. Ann Leahy MP, and will receive strategic oversight and advice from the Local Government Depreciation Executive Steering Committee (ESC), chaired by the Director-General of DLGWV.
- The final report is due to Minister Leahy by 31 December 2025. More information and Terms of Reference are available here.

12. Waste Update

Resource Recovery Boost Fund

- The Department of the Environment, Tourism, Science and Innovation (DETSI) have released program guidelines for the Resource Recovery Boost Fund (RRBF), a \$130 million package to support Queensland councils to address key waste reduction and recycling priorities, establish critical resource recovery infrastructure, divert waste, and increase recycling.
- The first funding round will see \$60 million available to eligible applicants across two funding streams;
 - Stream 1 (Small projects) \$20 million to support smaller-scale initiatives that provide waste management and/or resource recovery benefits at the local or regional scale.
 Individual project funding up to \$2 million (excl GST) with projects to be delivered within 18 months of contract execution.



- Stream 2 (Major projects) \$40 million to support more substantial undertakings that
 offer resource recovery solutions and economic benefits on a regional or statewide
 scale. Individual project funding over \$2 million (excl GST) with projects to be delivered
 within 3 years of contract execution.
- Applications are now open for the Resource Recovery Boost Fund (RRBF). Applications will close on the following dates:
 - o 3:00pm on Thursday 11 December 2025 for Stream 1, and
 - 3:00pm on Thursday 29 January 2026 for Stream 2.
- Details on how to apply and a link to the application portal is on the Department's website.

Inquiry into Improving Queensland's Container Refund Scheme

- On Thursday, 16 October 2025, the Health, Environment and Innovation Committee tabled Report No. 14, 58th Parliament – Improving Queensland's Container Refund Scheme.
- The report includes 21 recommendations made by the Committee to improve the scheme.
- The report and other documents relating to the Committee's inquiry can be viewed on the inquiry <u>website</u>.

Recycle Mate Workshops

- The Department of the Environment, Tourism, Science and Innovation held a series of workshops throughout November for local government representatives to learn about the Department's partnership with <u>Recycle Mate</u>.
- Six in person three-hour sessions were held, with one held in Cairns on Monday, 17 November.
 An online session was also held on 28 November.
- An Expression of Interest is currently open for all councils to access opt-in features as part of the Recycle Mate program. Complete the <u>online EOI form</u> by Friday 19 December 2025 to be considered for this opportunity.

LGAQ Circular Economy and Waste Management Advisory Group

- The LGAQ Circular Economy and Waste Management Advisory Group met for their fifth and final meeting of 2025 on 3 November.
- The meeting included updates from the LGAQ including a summary of the LGAQ Annual Conference resolutions.
- During the meeting, the Advisory Group was joined by external presenters from Recycle Mate and <u>Upparel</u>.
- The meeting Communique is currently under review and will be made available on Congruent.

Local Government Battery Collection Program

- On the 21 November, the Minister for the Environment, Tourism, Science and Innovation, the Honourable Andrew Powell, <u>announced</u> that 14 Queensland councils will receive more than \$1 million in funding grants to introduce new battery collection points and services across the state, giving households practical options to dispose of batteries.
- Local government Battery Collection Program recipients include:

End of Waste Codes – Annual call for submissions

13. Tourism Update

Tourism Icons Investment Fund (TIIF)

- The TIIF is an \$80 million program designed to support the development of infrastructure, attractions and experiences that exceed expectations, create jobs and help more tourismrelated businesses to grow.
- It will be delivered over four rounds with \$20 million available per round.
- Funding of up to \$5 million (ex GST) is available under Round 1 of the TIIF to eligible applicants and projects, and available funding is on a 1:1 co-contribution basis with applicants to contribute at least 50% of total eligible project costs (ex GST).
- Not-for-profit organisations and Queensland councils that provide a tourism service or experience are eligible to apply for funding under this program.



- Expressions of Interest (EOI) for Round 1 of the TIIF closed on 8 October 2025.
- Following assessment and shortlisting, eligible applicants with EOI registered projects that
 meet TIIF priorities may be invited to complete and submit a full business case application via
 the SmartyGrants portal by 8 December 2025.

14. Environment and Climate Update

Environment Protection and Biodiversity Conservation Act reforms – consultation open

- The Federal Government is proposing changes to reform Australia's national environmental laws, including the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act). A summary of the proposed EBPC reforms can be found on the <u>DEECCW website</u>.

Queensland bioregional planning – survey on early results

 - Wind farm developments in the Collinsville area in northern Queensland.
 - Minerals mining in the Julia Creek and Richmond area in north-western Queensland.
- DETSI are seeking feedback on methodology and results so far, in preparation for the draft bioregional plans for public consultation in 2026.
- The survey is quite technical in nature and builds on information gathered between July and October this year.

Queensland Biosecurity Grants Program- Round 2

16. Energy Update

Community Benefits Agreements

- Since the commencement of the Community Benefits Agreement (CBA) framework through amendments to the *Planning Act 2016* on 18 July 2025, development proponents have already started engagement with councils for renewable energy projects.
- The State Government has produced some guidance material, however, there remains a lack of clarity and certainty regarding the implementation of these changes.
- In addition, councils without in-house legal expertise have raised concerns regarding how CBAs should be prepared, what they should include and how they should be negotiated.
- To assist councils, the LGAQ has engaged King & Company to develop an easy-to-use template CBA with guidance notes that can be adopted by councils to support the new framework.
- King & Company are working with the LGAQ and councils that have experience working with energy proponents to assist in the development of the template and supporting materials.
- The LGAQ also facilitated fortnightly meetings with interested local government officers, to support councils' adoption of the new framework. A range of planning, economic development and community services officers have attended these meetings to share lessons, ask questions, and alert the LGAQ to concerns.
- A FAQs list has been developed from questions asked through this forum and the LGAQ is coordinating the responses with King & Company and the Department of State Development, Infrastructure and Planning for inclusion in the template.
- King & Company will work with a Queensland council to pilot the template using a live example.
- A draft has been provided to the LGAQ and shared for feedback with council officers.
- The LGAQ briefed the Energy and Resources Advisory Group on 3 October 2025 on the progress of this project and shared the draft for their input by 31 October 2025.



- The LGAQ Policy Executive was briefed and provided with the draft at their meeting on 19 October 2025.
- King & Co. presented at the Resource Councils Segment Session at the LGAQ Annual Conference on 20 October 2025.
- King & Co and the LGAQ are currently working through feedback received from councils and State Government before finalising the template and supporting materials for broader distribution.

LGAQ Energy and Resources Advisory Group

- At the June 2025 LGAQ Policy Executive meeting, PE members were briefed on and noted the proposed establishment of the Energy and Resources Advisory Group.
- On 19 August 2025, the LGAQ sent a targeted expression of interest for the Energy and Resources Advisory Group to councils most impacted by the resources and energy sector.
- This targeted approach focuses on councils that are experienced in the resources sector or have emerging renewable or energy hubs. This will ensure that representatives will be highly engaged, experienced and have specialised expertise in the energy and resource sector.
- The first LGAQ Energy and Resources Advisory Group was held on 3 October 2025, with the following key outcomes:
 - Mayor Kelly Vea Vea, Isaac Regional Council was nominated as Chair of the Advisory Group.
 - The group heard about the LGAQ's work program and discussed the Resources Segment Session at the LGAQ Annual Conference.
 - Members raised their biggest issues, with key themes around the energy transition and increased demands on housing, roads and water.
 - The Communique is currently being drafted and pending review by members it will be uploaded to Congruent.
