Mr. Gillespie has advised that TMR will be engaging a contractor to undertake investigations using LAMS (Laser Asset Management System). This can record start and stop chainages to high accuracy, provide defect magnitude (to allow prioritisation of effort) and provide a geometry (batter slope, distance to fog line form edge of seal, and edge drop or hinge point). Once TMR has this information they will then prioritise the most critical sections and undertake a remediation works to the extent that their current RMPC budget will allow.

Cr Hughes raised an issue with the uniformity of road shoulder works which in his experience varies significantly on both sealed and unsealed roads – some with severe angles, others not – which can cause an issue for cattle trucks. TMR requested that examples of issues identified be provided to TMR.

Cr Hughes also asked who within TMR would be prioritising the works. TMR advised that in this particular instance the decision would be made between Mr. Gillespie/Mr.Jones and their engineering staff.

529. PROGRAM UPDATE – MR DARRYL JONES, DISTRICT DIRECTOR (FAR NORTH), TMR

TIDS

- Expenditure at 87% as at the end of May, so on track to meet target by the end of financial year.
- Invoices to be provided please so that they can be paid and finalised by year end.

DRFA

- Major construction phase contracts have been issued for all DRFAs works required following Cyclone Jasper.
- 15 packages all up many of which have gone to local government represented in the room.

Palmerston

 Major works underway, piling is due to commence in the next month or so and soil nails progressing well.

Kuranda Range Road

- About to see a dramatic increase in activity, particular at night with up to 100 crew on site each night, Sunday through to Thursdays.
- Night closures expected to continue through to Christmas.

Captain Cook Highway

 No closures proposed through June but again works ramping up with additional crew now we are in the dry season so additional activity will be taking place in the area.

Mossman Daintree and Mount Molloy

 Recently commenced works with piling works next to the Daintree River and saw nailing and both sites.

Mayor Scomazzon advised that the Port Douglas tourist industry had recently sent a letter about road closures to TMR. Mr. Jones advised he had met with the tourist industry in Port Douglas two weeks ago and provided an overview of what was happening in the area, particularly on the Captain Cook Highway.

- Mr. Osman advised that a request had been made to provide one opening at 1.30am but pushing the closure time back from 9pm to 11pm.
- Mr. Jones advised productivity is critical and that they have a set time frame and budget for delivery based on the productivity rate. Reducing closure time will impact productivity and could potentially mean that TMR would be unable to deliver project on time and on budget.,
- Mr. Jones will arrange for the request to be reviewed and a response provided to the Tourist body.
- Mr. Jones also extended an offer to attend council meetings with either elected representatives or senior council staff to provide updates. He is keen to keep targeted conversations happening acknowledging that it is a disrupting activity that is taking place.
- Balancing the disruption but achieving productivity is key but it is important to ensure the works completed ahead of the next wet season.

Mayor Scomazzon asked if TMR could quantify the impact on productivity if road closures took place.

- Mr. Jones advised the budget for the works has been set with the Australian government and any cost overruns are met by the State.
- Potential for some works not to be completed if they cannot deliver on budget due to reduced productivity.

RTA TIDS

• FNQ RRTG expenditure is 87% as at 31 May 2025. Thanks to all councils and TMR District officers for taking steps to ensure 100% delivery by EoFY.

SCDF

• Of the \$600,000 available in 2025-26, \$123,000 has already been assigned to early applications. FNQ RRTG has made a great start with the Regional Road Surfacings Study.

RTA Annual Progress Report

- The <u>RRTG SharePoint page</u> now has a button for RRTGs to submit project stories for the 2024-25 Annual Report, with photos and consent forms as required.
- Note that the RRTG SharePoint page will be used to access TIDS resources and reference material. Please review and test functionality when time allows. All feedback is welcome.

TIDS Project Recognition Signage

• TMR are working with the Technical Committee to ensure we have pictures of all TIDS project recognition signs. None have been received to date.

Country Roads Connect Program

- Nominations closed on 2 May and have gone through an assessment process. Expect Ministerial decision later this month.
- FNQ Region councils submitted 21 project nominations, totalling \$66m of funding request. These nominations came from 12 councils, 7 of which are FNQ RRTG members.
- Note that this process also allowed us to identify 2 roads that should not be on the FNQ RRTG LRRS map. These have now been removed and updated maps posted online.

School Transport Infrastructure Program (STIP)

- Cassowary Coast Regional Council (Tully State High School) has been success for Tranche 8 funding. Councils can contact the STIP nominating officer in their council for more information.
- At this stage, only successful nominees have been contacted as there is no further information about STIP funding beyond Tranche 8.
- Councils may contact the STIP team in July after the budget process for any update that may be available, via STIP@tmr.qld.gov.au.

Local Government Red Tape Reduction Taskforce

- Established to identify unnecessary regulatory and legislative burdens that present a barrier to councils delivering services.
- The Taskforce consulted with all 77 Councils and the LGAQ to identify potential reforms.
- From the 1200 suggestions submitted, TMR received 19 proposed reforms for consideration.
- The Taskforce will provide a final report in June 2025 and LGP team will update once the report has been considered by Cabinet.

Temporary Traffic Management Working Group

 Last meeting held on 9 May. Note Khubaib Khan from Cook Shire Council and FNQ RRTG Technical Committee Chair – presenting the 2-year traffic controlling prerequisite work experience requirements agenda item.

531. LGAQ UPDATE – MR JARROD HELLMUTH, LEAD, ROADS & TRANSPORT, LGAQ

LGAQ Annual Conference Motions

- With the LGAQ Annual Conference scheduled for October, the Annual Conference motions portal will
 open on the 2nd of June 2025.
- If passed, these motions become resolutions that are recognised by other levels of government, other
 peak bodies and stakeholders as the accepted policy position of the sector and the LGAQ, and they
 are binding on the LGAQ team to progress.
- Motions should:
 - Relate to a statewide issue or an issue impacting a large portion or segment of the membership
 - o Ask for action from the State or Federal government
 - Not result in a responsibility or cost shift to local government
 - Not relate to a matter considered at a previous Annual Conference in the last five years, unless seeking to alter or update the adopted policy position.
- Motions close Monday 28 July 2025.

Quarries/borrow pits - Update - Section 143 of the Local Government Act

- The State Government has now received further legal advice that has strengthened councils' ability to use section 143 of the *Local Government Act 2009*.
- Historically, this section was only interpreted for immediate emergency or post-disaster works.
- The updated legal position now confirms that councils can also apply section 143 where it's reasonably impractical not to in other words, where using alternative sources would lead to significant time or cost blowouts.
- It's important that engineers and project teams are aware of this, as it can help avoid unnecessary delays or budget overruns in certain projects.
- However, councils will still need to assess each situation individually and document their justification when choosing to apply section 143.
- A key point to reinforce is that this change does not replace the need for councils to continue pursuing ILUAs and renewing sales permits under the *Forestry Act 1959* — the standard process remains the primary pathway for ongoing access.
- The current requirements under section 143 include providing 7 days' notice before entry.
- Material can be drawn from borrow pits up to 5,000 tonnes under this section.
- Extractions above 5,000 tonnes still trigger Environmental Authority requirements, and councils remain obligated to comply with Cultural Heritage legislation.
- In short, this new interpretation won't replace existing processes but provides an important additional tool to help councils avoid major cost and time pressures where appropriate.

Far North Queensland Roads Forum - Cairns Regional Council, Friday 27 June 2025

- We're pleased to share a date claimer for the upcoming Far North Queensland Road Forum a
 full-day event designed specifically to support local government officers, engineers and other staff
 involved in the transport infrastructure space.
- Attendance is completely free for councils, and participants will receive 7 CPD hours, making it an
 excellent opportunity to gain technical insights, connect with peers and explore regionally relevant
 approaches to resilient and sustainable road networks.

Road Closure and Use

- The Department is currently reviewing how road closures and permits to occupy are managed under the Land Act, with a focus on better aligning these processes with the Local Government Act and the responsibilities of councils as road managers.
- There's a clear recognition that the current framework creates duplication, delays, and inefficiencies—especially when temporary closures are used for long-term private purposes like grazing or cultivation.
- The Department is proposing to stop issuing new road licences under temporary closures, as more appropriate tenure options exist for those uses.
- For permanent closures, a key reform being considered is requiring formal local government consent before any closure under the Land Act proceeds. This would recognise councils' local expertise and planning responsibilities, while avoiding unnecessary administrative burden where a closure is unlikely to be supported.
- Similarly, the use of permits to occupy roads is being reassessed, with options on the table including requiring local government consent or phasing out the practice altogether.
- Feedback is being sought on how these proposals might impact councils, especially in rural and agricultural areas where such arrangements have historically been common.
- There are several options being assessed for temporary road closures, permanent road closures and permits to occupy which are detailed in the attached consultation paper.
- Feedback on behalf of each council would be appreciated prior to the 30th of June 2025.

Mayor Hughes acknowledged the work of LGAQ in their discussions with the State regarding quarry access both from an FNQROC perspective but also NWROC whose members are significantly impacted by the issue.

533. ROAD SAFETY

Mayor Holmes, Cook Shire Council to raise issues directly with TMR but then advised that the PDR heading North has several holes within the sealed section of road. Mr. Jones indicated that these may have recently been rectified but he will investigate further and provide an update.

ACTION POINT 533.1 Mr. Jones, TMR to investigate reported holes on sealed sections heading North on the PDR and provide an update regarding repair status.

Mr. Graffen, Cassowary Coast Regional Council advised that they had not yet received any information regarding the prioritisation of the works on the Bruce Highway. Mr Jones advised that this information will be shared once they are able to and issued a reminder that the focus was on safety not flood mitigation. Ongoing advocacy to be directed to both the North representative and the Minister.

Mayor Hughes asked for an update on the Hann Highway. Mr. Jones advised that TMR had just received approval to fund the work through DRFA and that an update had been sent to Etheridge Shire Council who had advised works would get underway in the next couple of days. Four sections to be repaired between chainage 77.4 and 82.4 with 2,500 tonnes of material required in various section of the roads.

Kiani Berzinski proposed the following wording in addition to the current wording in the FNQ Guidelines. This proposed additional wording was peer reviewed by Travis Mitchell and the following wording shared with the RRTG TC for consideration:

CONSIDERATIONS paragraph (page 2-3) to read:

The following are factors that need to be taken into consideration.

- Funding allocations must adhere to TIDS Policy Page 3 of 7
- 100% expenditure level target for TIDS Cost overruns are funded 100% by each member RRTG
- FNQ RRTG's Planning & Design Policy Design to be complete by the last meeting of the financial year prior to year of commencement.
- Maximum of 20% of TIDS can be allocated to Non LRRS annually.
- Maximum of 10% of TIDS can be allocated to State LRRS if funding is matched.
 - This excludes projects initiated by Local Government that involve:
 - New infrastructure within the State-controlled corridor where Local Government is solely responsible for funding construction as per the TMR/Local Government Cost Sharing Arrangement.
 - Renewal of existing infrastructure within the State-controlled corridor where Local Government is solely responsible for funding the replacement and maintenance, as per the TMR/Local Government Cost Sharing Arrangement.

This amended wording was reviewed agreed by the RRTG TC during the meeting. Endorsement of the amended wording to the FNQ Works Program – Development and Management Process regarding State-controlled roads to be sought from the RRTG at their meeting on 2 December 2025.

4.1. 2024/25 Completion

Amanda confirmed that 2024/25 claims had now been finalised with an underspend of \$49,190 – less than 1%.

4.2. New Projects

There were no new projects for consideration. Council officers were encouraged to consider identifying and inputting new projects given funding is available in the outer years.

4.3. Existing Projects

Changes to the program 2025-26, 2026-27 & 2027-28

Cairns Regional Council

ID275 – Lake Street – Lighting upgrade to Cat V3 along Lake Street from Lily St to Rutherford St to improve safety. Project costs increased from \$1m. Project currently underfunded.

ID273 – Lake Street – Lighting upgrade – Cat V3 along Lake Street from Charles St to Upward St to improve safety. Project costs increased to \$1.2M. Project currently underfunded.

ID286 – Aumuller Street – Renewal of 78m of concrete footpath. Project now complete so the project withdrawn. \$12,500 to be reallocated from 26/27.

Cassowary Coast Regional Council

ID305 – Mundoo Road 0 Bamboo Creek Bridge – replace existing single lane bridge with 2 lane concrete bridge. Project costs increased to in the region of \$4m. PMT not yet updated as project may be withdrawn. Decision pending.

ID356 – El-Arish – Mission Beach Road – State Road - Road Renew Pavement kerb and channel, pathways and stormwater. Awaiting updated project costs from Project Manager.

ID556 – Butler Street – Design and construction of intersection upgrade and asphalt overlay intersection of Butler St and Still St. Project is currently unfunded. Project to be completed in 25/26. Will take funding if it becomes available in 25/26 financial year but if not, project will be withdrawn. Potential banked project.

Douglas Shire Council

ID212 – Cape Tribulation Road – Resurfacing to improve safety. \$509,114 allocated in 27/28 as available. Project still underfunded.

Etheridge Shire Council

ID426 – Forsayth Road – State Road – Seal

Raju advised that council's application for Country Roads Connect funding was unsuccessful, so the project is withdrawn. \$608,256 funding to be reallocated from 27/28.

Raju advised that they like to seek funding for an alternative project, resealing of Forsayth Einasleigh Road, in 26/27.

Raju advised that this need to be submitted as a new project for admission into the program and funding would then be allocated according to Program Management Guidelines and funding availability.

Mareeba Shire Council

ID484 – Danbulla Forest Drive – Gravel Resheet. Project is currently unfunded. Project to be completed in 25/26. Will potentially take funding if it becomes available in 25/26 financial year but if not, project will be withdrawn. Potential banked project.

ID486 – Silver Valley Road – Replacement Bridge. Project is currently unfunded. Project to be completed on 25/26. Will potentially take funding if it becomes available in 25/26 financial year but if not, project will be withdrawn, Potential banked project.

ID488 – Tully Falls Road – Gravel Resheet. Project currently unfunded. Project to be completed in 25/26. Will potentially take funding it is becomes available in 25/26 financial year but if not, project will be withdrawn. Potential banked project.

ID490 – Tully Falls Road – Gravel Resheet. Project currently unfunded. Project to be completed in 25/26. Will potentially take funding if it becomes available in 25/26 financial year but if not, project will be withdrawn. Potential banked project.

Yarrabah Aboriginal Shire Council

ID417 – Workshop Road – Road Structure improvement of existing pavement, increase thickness and asphalt overlay, reconstruct kerb and channel and upgrade stormwater drainage. \$300,000 allocated as available in 27/28.

ID413 – Gribble Street – Roadworks. New Alignment – Bitumen Seal. This project is currently unfunded and non-LRRS. There was discussion regarding the application of RTA TIDS funding on indigenous non-LRRS roads noting indigenous council members of a RRTG are required to identify significant local roads, rather than LRRS.

ACTION ITEM 141.2 TMR to advise further regarding indigenous significant local roads and the application of the 20% non-LRRS limits using Project ID 413 Gribble Street as an example.

ACTION ITEM 141.3 YASC to update chainage and project information in the PMT for ID417 – Workshop Road

YASC planning to use their annual allocation in 25/26 on a planning study into a vehicle pull over area on Range Road. Project information to be input shortly.

2025-26, 2026-27 and 2027-28 are now fully allocated.

It was agreed that the allocation of funds for 2028-29 will be reviewed at the next RRTG TC on 14 November 2025 ready to seek endorsement by the RRTG on 2 December 2025.

5. TMR RAPT Update - Kirstin Knight, LG Partnerships, TMR

- The 2024-25 TIDS program was fully expended. Thank you to councils for your efforts in helping us reach this achievement.
- Statewide TIDS expenditure for end of September is sitting at just over \$7.3 million which represents 12% of total budget. The first quarter expenditure reports for 2025-26 have been issued to RRTGs for circulation to members and are available on the RTA SharePoint page. Please ensure any eligible expenditure is submitted to your local TMR district prior to end of month.
- RRTGs are encouraged to apply now for capability development and training through the Statewide Capability and Development Fund (SCDF) for the 2025-26 allocation. Of the \$600,000 available in 2025-26, approx. \$260,000 has been allocated as of 15 October 2025. SCDF applications should be submitted by end of February 2026.
- Each year, TMR invites eligible councils to submit applications for Aboriginal and Torres Strait Islander TIDS funding, which are then assessed and prioritised according to program criteria. Applications for 2026-27: Nominations will be sent to councils mid-November 2025 and will close 13 February 2026.
- Thank you to councils that provided contributions to the Roads and Transport Alliance Annual Progress Report. This year, the report will be published online link to report will be shared with the group when available.
- Congratulations to Mareeba Shire Council and Wujal Wujal Aboriginal Shire Council on being successful in
 obtaining funding through the Country Roads Connect (CRC) Program. The program was oversubscribed
 with over \$400m worth of nominations received. 22 projects across 22 local government areas were
 successful in obtaining funding through the CRC Program.
- The TIDS Project Recognition signage design files have been updated to reflect the current Queensland Government branding. The files are available on the RTA SharePoint site and the TIDS Project Recognition Policy will be updated in due course. Please ensure all new signs use the updated design files.

6. TMR - Local District Office Update - Louise Dutton & Jeremy Wienert, Program Delivery & Operations, TMR

- Bruce Highway Targeted Safety Program Announcement by the jointly funded AG:QG funded \$9B program early in 2025. 5 year program to be delivered by 2030. Program is developing. As yet list of projects have not been finalised. Early start funds have been released for a couple of construction projects and seed funding to get planning and design commenced.
- Barron River Bridge is progressing through development on the back of the announcement of the \$490M joint AG:QG funding earlier this year.
- Kuranda Range Road Safety and Resilience project- Progressing planning to identify the strategy of treatments to optimise improvements in safety and resilience on the range. Key focus is to reduce the unplanned closures of the range related to crashes, tree fall and slope failures.
- Planning team is finalising the Cairns Transport Study, co-partnered with Cairns Regional Council. This
 planning study is to develop the upgrade strategy and recommended future pipeline of investment for
 Cairns to facilitate and enable the forecasted growth and CRC's Cairns Growth Strategy. Noting the CRC's
 LGIP review, this will be considered within the strategy recommendations.

 Louise Dutton, MPPCM, is progressively working to engaged with Council infrastructure and planning teams across the region to build communication lines and collaboration. Initial meetings held with Cairns, Douglas, Cassowary Coast and Mareeba.

Travis Mitchell, CRC advised that council would like to see communications regarding decisions in managing roads where the impacts will directly affect the state and local network to be communicated as a joint decision or effort between the two agencies.

An example is where TMR projects impact movements on a connecting Council road (say closing a turning movement from a council road into a state road) and that being communicated to the community as a "council matter because it is a council road" even though it was done to accommodate the state project and not a priority of the Council.

Council would like to see communications reflecting a more aligned approach such as that Council and TMR are collaborating on these decisions and making joint decisions to manage the performance of the joint network.

The intent is to seem less disjointed and unaligned and reduce frustration from residents who have communicated to us that they are being given the run around and responsibility is being deflected.

ACTION POINT 141.6 TMR and CRC to develop a collaborative communications approach regarding decisions in managing roads that impact both the state and local network regardless of road ownership. Travis Mitchell asked for joint messaging where possible where issues are raised concerning roads that are not state-controlled.

7. LGAQ Update – Jarrod Hellmuth, LGAQ

• Regulatory change doubles ERA borrow pit threshold for regional councils

In August 2025, the Environmental Protection (Extractive Activities) Amendment Regulation 2025 came into effect – and the current ERA limit for smaller borrow pits of 5000 tonnes has been doubled to 10,000 tonnes in a calendar year before an environmental authority is required. This change marks a significant outcome for local government advocacy which will allow councils to more effectively maintain their road networks, deliver infrastructure projects, and reduce compliance burdens while continuing to operate within clear environmental safeguards. The LGAQ pushed hard for this change, and thank you to Banana Shire who raised this at our 2023 Annual Conference

• Native Title Quarries Update

The State Government is keen to hear from councils about your experience using the section 143 provisions to access state-owned quarry material.

Brought into place at the end of May, the section 143 of the LG Act legislative provision enables councils to access quarry pits for routine 'business as usual' activities, where there is no reasonably practicable alternative, under section 143 of the Local Government Act 2009 (the LGA).

 Accepted development requirements for operational work that is the constructing or raising of waterway barrier works

The new ADR introduces important updates for disaster recovery works on essential public assets. Councils are now able to repair or replace damaged infrastructure in a **like for like condition** within the same or similar footprint for government funded disaster recovery works, with scope for betterment where appropriate. This is a welcome change from the previous requirement to upgrade structures to a compliant design within two years, which placed significant pressure on smaller councils with limited revenue.

Since the initial consultation on the ADR 2.0 commenced, the Department has made a number of additional refinements of note:

- The requirement for a 'suitably qualified professional' to be physically present to oversee construction has been limited to rock ramp fishways only.
- o Streamlined requirements have been introduced for western drainage basins.
- o Greater flexibility is now provided for the use of gabions in common scenarios.

- Rock sizing requirements for aprons and waterway bed scour protection have been made more flexible across red, amber, and green waterways.
- Flexibility has been introduced around depth of cover requirements for culverts in green, amber, and red waterways, depending on culvert design and flow conditions.
- Upgraded engineering requirements for piers and piles have also been refined, allowing increased size upon replacement provided the cross-sectional area of the waterway is not reduced by more than 10 percent.

• Local Roads and Community Infrastructure (LRCI) Program

The Department of Infrastructure, Transport, Regional Development, Communications, Sport and the Arts has advised that councils have until 31 October 2025 to submit audited annual reports under the Local Roads and Community Infrastructure (LRCI) Program.

The construction period for approved LRCI projects ended 30 June 2024 for phases 1, 2 and 3, and 30 June 2025 for phase 4, and the program ends on 30 June 2026.

Unless the department has already approved an extension to allow projects to be completed during 2025-26, this is the last audited annual report that councils need to submit for the program.

8. Joint Purchasing & Resource Sharing

Amanda advised Regional Bitumen Reseal is underway and encouraged councils to consider any other services that may benefit from a collaborative procurement

9. Capability Agreement & Action Plan & SCDF

• Amanda advised that the current Capability Agreement & Action Plan needs to be reviewed and updated. There is an outstanding action for Amanda to review in the first instance and send to councils for input.

10. Points for noting to the FNQ RRTG or FNQROC Boards

Seek endorsement of the following:

- Recommended change to the Program Guidelines regarding State-controlled roads –see Item 138.2
- Recommended updated FNQ RRTG Constitution see Item 138.10

11. Other Business

4. Program

4.1. New Projects

19 new projects were reviewed and 17 admitted to the program to await funding to become available. These projects were as follows:

Douglas Shire Council

ID589 – Avalon Street – Renew the Cape Tribulation boardwalk.

- This proposed project was subject to debate regarding its suitability for inclusion in the TIDS program as it is a timber boardwalk that links pedestrians to the beach.
- The RTA Program Guideline clearly states that there of various types of infrastructure projects and activities that RRTGs can consider for inclusion in their programs including Active Transport Infrastructure and various work types that will improve the safety and environments of the network including pedestrian facilities.

- It was agreed that the project would be admitted but the score is relatively low at 10% as the project does not trigger a BCA or RRIS score, and it has limited MCA benefits. It will likely only be funded as a potential banked project.
- TMR confirmed that non-road projects are not considered non-LRRS for the purpose of the 20% maximum rule.

ACTION ITEM 142.1 Amanda to speak to Shepherd Services about the potential to add a section in the PMT for non-road projects. Section to potentially included pedestrian counts as opposed to vehicular counts and which can be discounted for the 20% LRRS calculation.

ID594 – Captain Cook Highway – Planning & design of Port Douglas-Mossman Rail Trail

- This proposed project was also subject to debate. Following closure of the Mossman Mill the project is for the planning and design the Port Douglas-Mossman rail trail on the site of the existing cane rail infrastructure.
- The consensus was that the project should include construction to realise the benefits claimed.
- The Program Guidelines also construction/delivery to be scheduled in the year following planning and design.
- It was acknowledged that this a project of potential significant strategic importance for both Douglas Shire Council and the region and that other partnership funding should also be explored.
- The project was not approved at this stage and the project was returned to Douglas Shire Council with a request for further information to be provided.
- ID562 Cooya Beach Road Construction of new footpath.
- ID567 Endeavour Street Construction of new footpath.
- ID590 Island Point Road Road upgrades including road widening, new shared path facility and lighting.
- ID583 Junction Road Replace and upgrade damage underground stormwater pipes.
- ID585 Junction Road Construction of shared path.
- ID592 Mossman Gorge Road Install lighting for new shared path.
- ID584 Mossman-Daintree Road & Newell Road Construct new shared path (Funding later allocated to this project see Item x).
- ID593 Port Douglas Esplanade Complete footpath missing link on Port Douglas Esplanade.
- ID568 Snapper Island Drive Install raised priority pedestrian crossing outside Wonga Beach State School.
- ID566 Ulysses Avenue Construction of new footpath.
- ID587 Whyanbeel Road Upgrade to sealed condition.
- ID588 Upper Cassowary Road Upgrade narrow single lane road to 2-lane seal. Amalgamation of previous project IDs 386, 494, 495 & 496 which are now withdrawn.

Mareeba Shire Council

ID580 – Springmount Road – Pavement strength improvement at the intersection with the sugar mill (Funding later allocated to this project – see Item 4.3)

ID576 – Springmount Road – Replacement of existing RCBC crossing with reinforced concrete bridge. Crossing located on MSC/TRC. Works within TRC will be required by agreement (Funding later allocated to this project – see Item 4.3)

ID582 – Springmount Road – Intersection upgrade with intersection with Chettle Road.

- BCA data was missing from project submission, so the project was not approved at this stage.
- Project returned to Mareeba Shire Council with a request for further information to be provided.

ID574 – Leadingham Creek Road – Widen and seal.

- New project initially submitted for inclusion in ID578 which is an amalgamation of previous projects ID242,244,248 and 250.
- However, as it is an additional new project, the committee requested it be submitted as a new individual project
- This is because if it is included in with the existing projects it will be given high priority for funding and possibly 'jump the queue' as councils with projects where they are funding over their 50% contribution are given priority for any available funding.

ID578 – Leadingham Creek Road – Widen and seal. Amalgamation of ID242,244,248 and 250 which are now withdrawn.

4.2. 2026/27 - Changes to Program

Funding was released and reallocated accord to the TIDS Program & Management Guidelines and Priority Ranking

Mareeba Shire Council

ID266 – Ootann Road – Roadworks (unsealed) – Existing Alignment – Seal and Widen.

Country Roads Connect funding received so project withdrawn. \$199,017 to be reallocated from 2026/27.

ID578 – Leadingham Creek Road – Widen and seal.

Additional funding of \$199,017 allocated in 2026/27 as next highest priority project.

Further \$295,983 allocated as available following reallocation of funding from 26/27 to 27/28 for ID550 – Cape Tribulation Road – see below

4.3. 2027/28 - Changes to Program

Cook Shire Council

ID505 – Bloomfield Road – Bridge Upgrade Works.

ATSI TIDS funding received so project withdrawn. \$177,500 to be reallocated from 2027/28.

ID361 – Bloomfield Road – Platypus Creek. Replacement and widening of existing causeway. DRFA funding received so project withdrawn. \$125,000 to be reallocated from 2027/28.

ID457 – Bloomfield Road – Reconstruction of concrete paving slab.

ATSI TIDS funding received so project withdrawn. \$600,000 to be reallocated from 2027/28.

Douglas Shire Council

ID212 – Cape Tribulation Road – Resurfacing.

Additional funding of \$70,036 allocated as funding available.

ID550 – Cape Tribulation Road – Daintree River Ferry Landside Infrastructure Funding of \$295,983 moved out to 2027/28

ID584 – Mossman-Daintree Road & Newell Road – Construct new shared path. \$263,981 allocated as available.

Mareeba Shire Council

ID576 – Springmount Road – Replacement of existing RCBC crossing with reinforced concrete bridge \$100,000 allocated as funding available.

ID580 – Springmount Road – Pavement strength improvement at the intersection with the sugar mill. \$172,500 allocated as funding available.

4.4. 2028-29

2028/29 remains unallocated. This will be the focus of the next RRTG TC.

ACTION ITEM 142.2 Seek endorsement by the RRTG of the updated 2025/26 – 2027/28 works program.

5. Road Treatment Study

- The draft Road Treatment Study Good Practice Guide provided by Phil Hunt of Road Engineering Services was circulated by email to the RRTG TC on 11 November 2025.
- Council officers encouraged to take the time to review and provide feedback.
- Thanks to Travis Mitchell, Cairns Regional Council and Khubaib Khan, Cook Shire Council for agreeing to work with Phil towards finalising the recommended report.
- Whilst the original intent was to have the guide completed by the end of the calendar year, we may need to push it out into the New Year if required, to ensure time for a detailed review.
- A reminder to councils also to provide Phil with the length and total area of council's asphalt and bitumen road network.

ACTION ITEM 142.3 Amanda to notify Phil Hunt of Road Engineering Services that Travis Mitchell, CRC and Khubaib Khan, CSC nominated to work with him to finalise the recommended Road Treatment Study – Good Practice Guide.

ACTION ITEM 142.4 Councils to provide Phil Hunt, Road Engineering Services with the length and total area of their asphalt and bitumen road network if they have not already done so.

6. TMR RAPT Update Jill Barry, LG Partnerships, TMR

TIDS expenditure

- Statewide RTA TIDS expenditure for 2025-26 was 18% to the end of October.
- FNQRRTG RTA TIDS expenditure for 2025-26 was 13% to the end of October.
- FNQRRTG RRTG ATSI TIDS (Wujal Wujal and Yarrabah) expenditure for 2025-26 was 0% to the end of October.
- Reminder to submit any claims for eligible expenditure
- Reminder that projects which have a total TIDS contribution of \$250,000 or greater are required to have standard TIDS project signage erected.

SCDF

• It was noted that FNQRRTG has approved 50% SCDF funding for their regional road surfacing study this financial year. Please provide any updates on delivery status/expected completion.

Council road crash data

- TMR's Safer Roads Team will now provide the crash data on a quarterly basis (was 6 monthly).
- It can be used to support applications to road safety funding programs like Blackspot.

7. LGAQ Update - Jarrod Hellmuth, LGAQ

- Working on motions arising from the LG Conference including LG Charter with Ergon
- Quarry material ILUA negotiations ongoing. Please can any councils using S.143 share their experiences with LGAQ
- Some positive change to water barrier works requirements impacting some councils.

8. Temporary Traffic Management – TMR Development Library

Amanda circulated an email on 6 November 2025 advising that TMR have launched a Temporary Traffic Management (TTM) Occupational Group in the Department of Transport and Main Roads (TMR)'s online Development Library.

TMR advise that the TTM Development Library has been created to:

- provide accessible, high-quality training resources for all stakeholders involved in TTM
- build capability across the industry by improving understanding of roles, responsibilities, and best practices
- improve delivery performance and reduce costs by fostering a more informed and safety-conscious workforce.

9. TMR State Network Assessment

- At the recent LGAQ Conference there was a half day road component, and the CEO for the National Transport Research Organisation (NTRO) presented on several initiatives including iPAVE (Intelligent Pavement assessment Vehicle).
- iPAVE assesses TMRs State Network annually and NTRO are keen to see this assessment being from on Local Government LRRS roads at the same time, ideally at no cost to councils.
- Historically the State has previously funded asset data collection through SCDF i.e. NetRisk 2009, 2010, 2011,2012
- It was agreed that it would be beneficial to raise this with the RRTG to progress this advocacy.

ACTION ITEM 142.5 State funding for asset condition assessments on Local Government LRRS roads to be raised with the RRTG to potentially progress advocacy.

10. Regulatory Impact Analysis to reduce the open road default limit and National Road Safety Strategy

- Amanda advised that the Department of Infrastructure, Transport, Regional Development,
 Communications, Sports and Arts are undertaking a Regulatory Impact Analysis to reduce the open road default speed limit.
- Reform options include:
 - Sealed Roads
 - Option 1 90 km/hr
 - Option 2 80 km/hr
 - Option 3 70 km/hr
 - o Unsealed Roads
 - Option 1 80 km/hr
 - Option 2 70 km/hr
- LGAQ is seeking feedback on the proposed changes and Darlene Irvine, FNQROC CEO provided feedback which was circulated both to the RRTG TC and LGAQ.
- In addition, public feedback is also being sought to inform the National Road Safety Strategy as part of a mid-term review.
- Jarrod at LGAQ kindly advised that he would share copies of their submissions.

ACTION ITEM 142.6 Jarrod Hellmuth, LGAQ to share copies of LGAQ's submissions to the RIA to reduce the open road default limit and National Road Safety Strategy.

11. TMR - Local District Office Update - John Gillespie, TMR

John Gillespie advised that ATSI nominations forms have been sent for the 2026/27 funding round which closes on 13 February 2026.

12. Points for noting to the FNQ RRTG or FNQROC Boards.

The following matters were identified at the RRTG TC Meeting No. 141 on 15 October 2025 to be raised with the RRTG:

Item 138.2 Seek endorsement by the RRTG of proposed amended wording to the FNQ Works Program – Development & Management Process regarding used of TIDS funding on State-controlled roads.

Item 138.10 Seek endorsement by the RRTG of the update constitution.

In addition, the following matters are also to be raised:

Item 142.2 Seek endorsement by the RRTG of the updated 2025/26 - 2027/28 works program.

Item 142.5 State funding for asset condition assessments on Local Government LRRS roads to be raised with the RRTG to potentially progress advocacy.

13. Proposed new LRRS roads - Mareeba Shire Council

- Amanda advised that three additional roads to be added to the LRRS network have been nominated by Mareeba Shire Council and a Statement of Intent (SOI) for each road was circulated by email on 11 November 2025.
- The RRTG TC must now consider each proposed road and decide if they wish to recommend approval of the road to the LRRS network to the RRTG.
 - a. If it is recommended that the road be approved, endorsement will then be sought from the RRTG.
 - b. If it is recommended that the road is not approved, the nominating council can either decide to accept the decision of the RRTG TC or raise the matter with the RRTG for further consideration.
- According to the RTA Operational Guidelines, LRRS roads are determined by the RRTG to focus TIDS
 investment on roads or strategic importance. The RRTG establishes the eligibility criteria appropriate for
 their LRRS network and use on or more of the following criteria as a guide, for example, the roads:
 - a. forms an important part of the economic development strategy of the region, including access to natural resources, agricultural areas, industrial zones and attractions of regional significance
 - b. provides access to rail heads, freight depots, ports and major airfields from a higher order road
 - c. connects shires, towns, cities and regions and provides travel time and distance savings
 - d. provides a connecting function across a local government boundary
 - e. acts as a significant commuter route, that is, urban roads providing travel and distance savings
 - f. provides access to regionally significant institutions like community health, education, recreation, youth, aged care and entertainment facilities
 - g. provides the only access to a remote community
 - h. provides emergency access
- The three roads nominated are:
 - a. Tinaroo Creek Road
 - b. Ray Road
 - c. Oak Forest Road
- Oak Forest Road was previously a LRRS road but was removed.
- Following brief discussion, the general consensus was that of each of the roads, Tinaroo Creek has the most potential to be a LRRS, but the others appear to be of local as opposed to regional significance.
- It was noted that during previous reviews, roads were considered against an agreed criterion.
- As not all attendees had had the opportunity review the SOIs ahead of the meeting it was agreed that the
 matter be carried over to the next RRTG TC with details of the previously used criteria be circulated ahead
 of the meeting together with the reasons why Oak Forest Road was previously removed from the LRRS
 register.

ACTION ITEM 142.7 Amanda to circulate previous criterion used to determine LRRS roads together with reason why Oak Forest Road was previously removed from the LRRS register.

ACTION ITEM 142.8 RRTG TC to consider SOIs submitted by MSC ready for discussion at the next RRTG TC.



ABOUT THE ROADS AND TRANSPORT ALLIANCE

The Roads and Transport Alliance (the Alliance) is a cooperative governance arrangement between the Department of Transport and Main Roads (TMR), and Queensland local governments to invest in and regionally manage the Queensland transport network. Established in 2002, the Alliance was formed to jointly address shared road and transport challenges and deliver improved value from all available resources.

- The original 5 year Memorandum of Agreement (MoA) establishing the Alliance was signed on 28 August 2002.
- In response to local government reform, the MoA was extended for 12 months up until August 2008.
- Following this extension, a new MoA was endorsed on 2 September 2008 extending the agreement from 2008-2013.
- A new MoA was endorsed on 31 July 2013 extending the agreement from 2013-2018.
- A new MoA was endorsed on 29 October 2018 extending the agreement from 2018-2023.
- A new Roads and Transport Coordination, replacing the MoA, was endorsed on 14 October 2022.

Name changes from "Roads Alliance" to "Roads and Transport Alliance" and "Regional Road Group" to "Regional Road and Transport Group" were also effected on 31 July 2013.

The objectives of the Alliance are:

- Benefit-focused maximise the investment on Queensland's road and transport network to achieve economic, social, and environmental benefits
- Collaborative achieve maximum efficiencies through collaboration and innovation in network planning, program development and delivery
- Capability development improve technical skills through training, technology, and knowledge transfer
- Safe and efficient road and transport network optimise road safety on Queensland's road and transport network.

TMR provides funding support to local governments for transport related initiatives through the Transport Infrastructure Development Scheme (TIDS). TIDS funds are to be matched by local governments.

Regional Roads and Transport Groups (RRTG) are the primary decision-making bodies of the Alliance. RRTGs are based on existing relationships taking into consideration economic, social, environmental, and geographic characteristics of a region, which serve to influence the planning and management of the regional transport network and the services provided by that network.

This document represents the Constitution of the Far North Queensland Regional Roads and Transport Group (including its Technical Committee).

1. OPERATIONAL ARRANGEMENTS FOR THE REGIONAL ROADS AND TRANSPORT GROUP

1.1 Operational Guidelines

The Alliance Operational Guidelines provide the basis for the governance and operational procedures adopted by the Far North Queensland Regional Roads and Transport Group. This Constitution is consistent with these Operational Guidelines.

1.2 Responsibilities

The RRTG is responsible for:

- Managing the Alliance TIDS program and its investment on the regional transport network.
- Determining the Local Roads of Regional Significance (LRRS) network and notifying the Roads and Transport Alliance Project Team (RTAPT) of changes to the network.
- Determining and approving the long-term investment strategies for the region's LRRS network.
- Ensuring local governments' commitment to the transport network in real terms is maintained and any additional state funding over and above this commitment is matched with local government funds.
- Ensuring that the rolling four-year works program is submitted annually to the appropriate TMR district office(s) by the end of February of each year.
- Planning and reporting improvement in the capacity and coordination in four key road stewardship capabilities: program development, asset management, road safety, and joint purchasing and resource sharing (JP&RS).
- Ensuring the annual Alliance TIDS allocation is spent in accordance with the TIDS Policy.
- Ensuring that project recognition signs are installed in accordance with the TIDS Project Recognition Policy.
- Any other roads or transport responsibility deemed appropriate, beneficial and a priority for the region.

1.3 Membership

1.3.1 Members

The Far North Queensland Regional Roads and Transport Group comprises:

- Cairns Reginal Council
- Cassowary Coast Regional Council
- Cook Shire Council
- Croydon Shire Council
- Douglas Shire Council
- Etheridge Shire Council
- Mareeba Shire Council
- Tablelands Regional Council
- Wujal Wujal Aboriginal Shire Council
- Yarrabah Aboriginal Shire Council
- Transport and Main Roads Far North Queensland

1.3.2 <u>Membership</u>

The RRTG is responsible for agreeing on Council membership and the TMR Director General must endorse membership or changes to membership. Changes to membership must be in writing to the Chair of the RRTG, and if supported by the RRTG, in writing to the TMR Director General.

1.3.3 Withdrawal

A Member Council may withdraw at anytime from the RRTG, however, the withdrawing Member Council must honour any Alliance commitments previously made by that Member Council.

1.3.4 Representatives

Each Member Council may nominate one (1) elected member as its delegate on the RRTG. If the nominated delegate/s are unable to attend meetings of the RRTG, the Member Council will appoint another elected member as their alternate delegate.

The TMR delegate shall be the District Director. If the District Director is unable to attend meetings of the RRTG, the District Director will appoint a senior officer as his/her alternate delegate.

1.3.5 Observers

All Members of the RRTG shall be entitled to have in attendance at each meeting of the RRTG one observer to act as advisor.

Non-Member Councils may attend RRTG meetings in observer status with the agreement of Members. Observers are not entitled to vote but may address the RRTG with the agreement of Members.

1.4 Office Bearers

1.4.1 Chair

The RRTG will elect a Chair to conduct RRTG meeting procedures and to control and arrange the affairs of the RRTG.

1.4.2 Deputy Chair

The RRTG will elect a Deputy Chair who shall conduct proceedings in the Chair's absence.

1.4.3 Filling of Vacancies

Where a vacancy of office occurs, the RRTG at its next meeting subsequent to the vacancy occurring will by resolution appoint a delegate to fill the vacancy.

1.4.4 Term of Office

An election will be held for the Chair and Deputy Chair of the RRTG at the first RRTG meeting following the date of state wide Local Government elections. The Chair and Deputy Chair will be appointed for a one (1) year term.

1.5 Meetings

1.5.1 Frequency

Meetings are to be held at least two times per year. Any Member may request the Chair to convene additional meetings. Video conference and telephone conference are an acceptable form for meetings.

1.5.2 <u>Dates</u>

A schedule of meeting dates is to be agreed to by Members for a twelve-month period.

1.5.3 Agenda

A meeting agenda is to be compiled and sent to all Members at least seven (7) days prior to the meeting date.

1.5.4 Minutes

Minutes of meetings are to be prepared by the Secretariat and sent to all Members within fourteen (14) days of the meeting.

1.5.5 Objectives and Milestones

Meetings should include consideration of:

- Regional Investment Strategy setting the vision and strategic transport-related objectives for the region.
- Works Program moderate the annual four-year works program across all infrastructure types and ensure the works align with the regional investment priorities for the region.

- Joint Purchasing and Resource Sharing discuss opportunities to work collaboratively to generate efficiencies.
- Safety discuss any safety issues or opportunities.
- LRRS Network review and endorse LRRS change requests recommended by the Technical Committee.
- Works Delivery monitor the delivery of the works program and claims for reimbursement of Alliance TIDS funding for the current financial year.
- Capability Agreement and Action Plan monitor and consider the Capability Agreement and Action Plan for current and future financial years.
- Strategic Issues discuss any road and transport matters.

1.6 Decision-Making

1.6.1 Consensus

All decisions in the first instance should be achieved via consensus. Where a consensus is not reached, the RRTG will vote to resolve the issue. Decisions may be made between meetings, providing all Members have been given appropriate opportunity to consider the issues. Decisions can be made via email, providing the email trail includes each Member's position.

1.6.2 Voting

Each Member with a delegate/s in attendance at the meeting is entitled to one vote. In the event of an equality of votes on any issues, the Chair may exercise a second or casting vote. Voting for decisions made between meetings must be recorded by email.

1.6.3 Quorum

A quorum shall comprise half plus one of all Members of the RRTG.

1.6.4 Issue Resolution

Where issues cannot be satisfactorily and expeditiously resolved, the following principles will apply to the issue resolution process which align with the Alliance Operational Guidelines:

- Issues are to be resolved at the lowest possible level.
- At each level, the issue must be resolved or passed to the next highest level within a reasonable timeframe.
- Issues are to be dealt with in an expeditious manner within the spirit of the Alliance.

If the RRTG cannot resolve an issue, the RTAPT should be advised within 5 days. If the issue cannot be resolved with RTAPT assistance, the TMR Director General has authority to make a decision.

1.7 Sub-Committees

1.7.1 Role

The Far North Queensland RRTG comprises one large committee, should the RRTG decides to introduce sub-committees of the RRTG, the role of the sub-committees is to undertake tasks as determined by the RRTG.

The RRTG will retain primary responsibility for the:

- Governance arrangements for the RRTG
- Technical Committee/support
- Network identification, vision, performance standards

1.8 Secretariat Services

1.8.1 Role

The RRTG will appoint a Secretariat to provide the following services to the RRTG and the Technical Committee if necessary:

- Manage the administration funds of the RRTG.
- Minute and record the appointment of Chairs, Deputy Chairs, and Members of the RRTG and Technical Committee.
- Keep minutes and records of the names of Members' delegates of the RRTG and Technical Committee present at meetings.
- Prepare agendas for meetings of the RRTG and Technical Committee.
- Make necessary arrangements for meetings of the RRTG and Technical Committee.
- Enter into such correspondence as may be required from time to time by the RRTG and Technical Committee.
- Undertake the general administration of the business of the RRTG and Technical Committee.
- Perform such duties and functions as determined by the RRTG and Technical Committee in accordance with these rules and inform the Chair regularly of all relevant activities.
- Coordination of Member TIDS funding applications for capability development.
- Coordination if required, of the technical tasks undertaken by the Technical Committee.

1.8.2 Appointment

The RRTG appoints Far North Queensland Regional Organisation of Councils (FNQROC) AS THE Secretariat until terminated by resolution.

1.9 Funding

1.9.1 Alliance TIDS

The RRTG receives a single annual allocation of Alliance TIDS funds. The RRTG is required to allocate this funding in a regionally prioritised two-year fixed, two-year indicative continuous works program, consistent with the TMR QTRIP development cycle.

1.10 Communication

1.10.1 Spokesperson

The Chair will be the official spokesperson for the RRTG.

1.10.2 Funding Announcements on LRRS Network

For announcements with regard to project approvals, the arrangements will be in accordance with the TIDS Project Recognition Policy.

2. OPERATIONAL ARRANGEMENTS FOR THE TECHNICAL COMMITTEE

2.1 Responsibilities

The Technical Committee is responsible for:

- Providing recommendations on the composition of the LRRS network for endorsement by the RRTG
- Developing and regularly reviewing the long-term investment strategies (Statements of Intent) on the LRRS network and submitting them to the RRTG for discussion and approval.
- Adopting program development tools and practices that enable regional prioritisation and allocation of the investment on the LRRS network.
- Proposing, prioritising, and finalising the draft annual four-year works program for approval by the RRTG.
- Monitoring expenditure on Alliance TIDS-funded projects, ensuring TIDS reimbursement claims are submitted and processed in a timely manner, and keeping the RRTG informed of progress throughout the year.
- Developing and regularly reviewing a Capability Agreement and Action Plan to continually improve the RRTG's capability in program development, asset management, road safety, and JP&RS, and reporting against these actions to the RRTG.
- Ensuring timely execution of the actions in the Capability Agreement and Action Plan.
- Providing recommendations to the RRTG for decision-making in general on any other roads or transport responsibility deemed appropriate, beneficial, and a priority for the region.

2.2 Membership

2.2.1 Representatives

Each Member Council may nominate one (1) senior staff representative, or engineering consultant engaged by the Member Council, as its delegate on the Technical Committee. If the nominated delegate is unable to attend meetings of the Technical Committee, the Member Council will appoint another senior staff representative as their alternate delegate.

TMR may nominate one (1) senior staff representative as its delegate on the Technical Committee. If the nominated delegate is unable to attend meetings of the Technical Committee, TMR will appoint another senior staff representative as their alternate delegate.

2.2.2 Observers

Other Member Council and TMR staff representatives may attend Technical Committee meetings as observers. Staff representatives from Non-Member Councils may attend Technical Committee meetings in observer status with the agreement of Members. Observers are not entitled to vote but may address the Technical Committee with the agreement of Members.

2.3 Office Bearers

2.3.1 Chair

The Technical Committee will elect a Chair to conduct Technical Committee meeting procedures and to control and arrange the affairs of the Technical Committee.

2.3.2 Deputy Chair

The Technical Committee will elect a Deputy Chair who shall conduct proceedings in the Chair's absence.

2.3.3 Filling of Vacancies

Where a vacancy of office occurs, the Technical Committee at its next meeting subsequent to the vacancy occurring will by resolution appoint a delegate to fill the vacancy.

2.3.4 Term of Office

The Chair and Deputy Chair of the Technical Committee will be appointed or a one (1) year term and may seek re-election.

2.4 Meetings

2.4.1 Frequency

Meetings are to be held at least four times per year. These meetings will generally precede the RRTG meetings to allow technical recommendations to be presented to the RRTG meeting. Video conference and telephone conference are an acceptable form for meetings.

2.4.2 Dates

A schedule of meeting dates, based on RRTG meeting dates, is to be agreed by Members for a twelvemonth period.

2.4.3 Agenda

A meeting agenda is to be compiled and sent to all Members at least seven (7) days prior to the meeting date.

2.4.4 Minutes

Minutes of meetings are to be prepared by the Secretariat and sent to all Members within fourteen (14) working days of the meeting.

2.4.5 Objectives and Milestones

Meetings should allow the Technical Committee to:

- Works Program develop the annual four-year works program, under the management of the RRTG, from approximately August to February, including the proposal of projects, their prioritisation and the submission of a recommended program to the RRTG.
- LRRS Network review and update the LRRS network as required by the region's circumstances.
- Regional Investment Strategy review and update investment strategies for the LRRS network as required by the region's circumstances.
- Works Delivery manage the delivery of the works program and claims for reimbursement of Alliance TIDS funding for the current financial year, including expenditure target requirements.
- Capability Development nominate, and when approved, execute opportunities for capability improvement in program development, road safety, asset management, and JP&RS.
- Capability Agreement and Action Plan Implement the actions in the Capability Agreement and Action Plan for the current financial year.
- Strategic Issues discuss other road and transport matters of regional significance.

2.5 Decision-Making

2.5.1 Consensus

All decisions in the first instance should be achieved via consensus. Where a consensus is not reached, the Technical Committee will vote to resolve the issue. The views/comments of dissenting Members will be comprehensively documented in the minutes of the meeting for the information of the RRTG.

Decisions may be made between meetings, providing all Members have been given appropriate opportunity to consider the issues. Decisions can be made via email, providing the email trail includes each Member's position.

2.5.2 Voting

Each Member with a delegate in attendance at the meeting is entitled to one vote. In the event of an equality of votes on any issues, the Chair may exercise a second or casting vote.

2.5.3 Quorum

A quorum shall comprise half plus one of all Members.

2.5.4 Issue Resolution

| Issues, where they arise, should initially be resolved at the Technical Committee level. Technical Committee consensus, the matter will be referred to the RRTG for resolution. | Failing |
